The applicant **Douglas County**, hereby make application for permission to change the **Point of Diversion & Place of Use** of water heretofore appropriated under **Permit 53011**

1. The source of water is **Underground**
2. The amount of water to be changed **1.0 CFS, not to exceed 73.0 MGA**
3. The water to be used for **Quasi-Municipal**
4. The water heretofore permitted for **Quasi-Municipal**
5. The water is to be diverted at the following point **NW¼ of the SE¼ of Sec. 32, T.14N., R.20E., M.D.B.&M., at a point from which the NE corner of Sec. 32 bears N 32° 11' 32" E., a distance of 4640.30 feet.**
6. The existing permitted point of diversion is located within **SE¼ NE¼, Sec. 5, T.13N., R.20E., M.D.B.&M. or at a point from which the N ¼ corner of Sec. 4, T.13N., R.20E., M.D.B.&M., bears N. 59° 06' E. a distance of 3528 feet.**
7. Proposed place of use **See Attachment "A"**
8. Existing place of use **E½ Sec. 5; W½ Sec. 4; W½ Sec. 9; E½, SE¼ SW¼ & a portion of SW¼ SW¼ Sec. 8; E½, NE¼ NW¼ & a portion of NW¼ NW¼ of Sec. 17; W½ Sec. 16; a portion of NE¼ NE¼ of Sec. 20; and a portion of NW¼ NW¼ Sec. 21, all in T.13N., R.20E., M.D.B.&M., Douglas County Nevada.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Existing drilled and cased well, pump, motor and distribution system.**
12. Estimated cost of works **\$600,000.00**
13. Estimated time required to construct works **Complete, see Permit 63817-T**
14. Estimated time required to complete the application of water to beneficial use **Five (5) years**
15. Remarks: **The map for the new East Valley Water System Service Area is on file with the State Division of Water Resources under Permit 63817-T. This map illustrates the proposed point of diversion and the proposed place of use.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 53011 is issued subject to the terms and conditions imposed in said Permit 53011 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The well must be sealed with cement grout, concrete grout or neat cement from ground level to 100 feet.

The total combined duty of water under Permits 65865 and 65866 shall not exceed 73.0 million gallons annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The permittee shall report to the State Engineer on a quarterly basis the effect of pumping the well under this permit on other previously existing wells that are located within 2,500 feet of the well under this permit.

Any pumping of water under this permit may be limited or prohibited to prevent any unreasonable adverse effects on an existing domestic well located within 2,500 feet of the well under this permit, unless the holder of this permit and the owner of the domestic well have agreed to alternative measures that mitigate adverse effects.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.0 cubic feet per second, but not to exceed 73.0 million gallons annually.




