The applicant **Sierra Pacific Power Company**, hereby makes application for permission to change the **Point of Diversion, and Place of Use** of water heretofore appropriated under **Permit No. 25118, Certificate No. 7215**

1. The source of water is **the Truckee River**
2. The amount of water to be changed **3.55 c.f.s. but not to exceed 638.6 acre feet**
3. The water to be used for **Municipal and Domestic**
4. The water heretofore permitted for **Municipal and Domestic**
5. The water is to be diverted at the following point **The points of diversion of Sierra Pacific's existing water treatment Plants as described in attached Exhibit "A" and as shown on the map supporting Application No. 58882 on file with the Division of Water Resources, State of Nevada.**
6. The existing permitted point of diversion is located within. **Situate in the SE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 10, T.19N., R.19E., M.D.B.&M., or at a point which from the Southeast corner of said Section 10 bears South 69°57'58" East, a distance of 842.34 feet (Idlewild Pump Station). Please refer to map on file under Permit No. 25106 in the office of the Division of Water Resources, State of Nevada.**
7. Proposed place of use **See attached Exhibit "B" as described in Application No. 62141 and shown on supporting map accompanying said application on file with the Division of Water Resources, State of Nevada.**
8. Existing place of use **Sections 34, 35 & 36, T.20N., R.19E., Sections 31, 32 & 33, T20N, R20E; Sections 4, 5, 6, 7, 8, 9, 17, 18, 19, 20, and 30, T19N, R20E; and Sections 1, 2, 3, 4, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 20, 21, 22, 23, 24, 25, 26, and 27, T19N, R19E, all in MDB&M, Washoe County, Nevada. Please refer to map on file under Permit No. 25106 in the office of the Division of Water Resources, State of Nevada.**
9. Use will be from **January 1* to December 31*** of each year.
10. Use was permitted from **As Decreed.**
11. Description of proposed works **Water will be diverted at existing SPPCo facilities, then, treated and placed into its existing distribution system.**
12. Estimated cost of works **Completed**
13. Estimated time required to construct works **Completed**

14. Estimated time required to complete the application of water to beneficial use **3 years**

15. Remarks: ***Not to exceed a maximum of 25% per month. These rights are currently Permitted to the Idlewild Water Treatment Plant and the Plant is no longer in use. Sierra Pacific is changing these rights to its multiple Points of Diversion for use in its expanded Place of Use.**

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of the Truckee River as heretofore granted under Permit 25118, Certificate 7215, which changed the point of diversion, place of use, and manner of use of a portion of Claim No. 514, Truckee River Decree is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein. A suitable measuring device must be installed and accurate measurements of water placed to beneficial use must be kept.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.



The following describes the multiple points of diversion for Sierra Pacific Power Company Water Treatment Plants, which are shown on the map accompanying Application No. 58882 on file with the State of Nevada, Division of Water Resources, more particularly described as follows:

STEAMBOAT CANAL (HUNTER CREEK RESERVOIR):

The existing point of diversion is situate within the Northeast one-quarter of the Southwest one-quarter (NE1/4 SW1/4) of Section 31, T.19N., R.18E., M.D.B.&M., Washoe County, Nevada, from said point of diversion, the Southeast corner of said Section 31 bears South 62°04' East, a distance of 3,195.00 feet.

HIGHLAND DITCH (HIGHLAND RESERVOIR):

The existing point of diversion is situate within the Southwest one-quarter of the Southeast one-quarter (SW1/4 SE1/4) of Section 9, T.19N., R.18E., M.D.B.&M., Washoe County, Nevada, from said point of diversion, the Southeast corner of said Section 9 bears South 75°16' East, a distance of 1,650.00 feet.

IDLEWILD TREATMENT PLANT:

The existing point of diversion is situate within the Southeast one-quarter of the Southeast one-quarter (SE1/4 SE1/4) of Section 10, T.19N., R.19E., M.D.B.&M., Washoe County, Nevada, from said point of diversion, the Southeast corner of said Section 10 bears South 69°57'58" East, a distance of 842.34 feet.

NORTH TRUCKEE DITCH (GLENDALE TREATMENT PLANT):

The existing point of diversion is situate within the Southwest one-quarter of the Northeast one-quarter (SW1/4 NE1/4) of Section 7, T.19N., R.20E., M.D.B.&M., Washoe County, Nevada, from said point of diversion, the Northeast corner of said Section 7 bears North 39°28' East, a distance of 3,015.00 feet.

ORR DITCH PUMP STATION (CHALK BLUFF TREATMENT PLANT):

The point of diversion is situate within the Northeast one-quarter of the Southeast one-quarter (NE1/4 SE1/4) of Section 17, T.19N., R.19E., M.D.B.&M., Washoe County, Nevada from said point of diversion the Northeast corner of said Section 17 bears North 15°39'36" East, a distance of 3,264.77 feet.

ORR DITCH (CHALK BLUFF TREATMENT PLANT):

The point of diversion is situate within the Northeast one-quarter of the Southwest one-quarter (NE1/4 SW1/4) of Section 17, T.19N., R.19E., M.D.B.&M., Washoe County, Nevada from said point of diversion the Southwest corner of said Section 17 bears South 44°40' West, a distance of 3,211.00 feet.
