The applicant **Cortez Joint Venture**, hereby makes application for permission to change the **point of diversion and place of use** of water heretofore appropriated under **Permit #62977**

1. The source of water is **Underground (Well #DB-12)**
2. The amount of water to be changed **1.9688 c.f.s. (842.6 acre-feet)**
3. The water to be used for **irrigation**
4. The water heretofore permitted for **irrigation**
5. The water is to be diverted at the following point **within Lot 10, Section 31, T.28N., R.47E., M.D.M. from which the NE corner of said section bears N.49°51'E., 3,467 ft. dist.**
6. The existing permitted point of diversion is located within **SE<sup>1</sup>/<sub>4</sub> SW<sup>1</sup>/<sub>4</sub> Section 17, T.28N., R.48E., M.D.M., from which the SE corner of said section bears S.72°39'30"E., 3,091 feet**
7. Proposed place of use **T.28N., R.48E., M.D.M., Section 9: SW<sup>1</sup>/<sub>4</sub>, Section 16: NW<sup>1</sup>/<sub>4</sub>, Section 17: all, Section 18: E<sup>1</sup>/<sub>2</sub> SE<sup>1</sup>/<sub>4</sub>**
8. Existing place of use **T.28N., R.48E., M.D.M. 210 acres within Section 9: SW<sup>1</sup>/<sub>4</sub>, Section 16: NW<sup>1</sup>/<sub>4</sub>, Section 17: S<sup>1</sup>/<sub>2</sub>**
9. Use will be from **April 1 to November 1** of each year.
10. Use was permitted from **April 1 to November 1** of each year.
11. Description of proposed works **Drilled & cased well (existing), with gravel packing, Submersible pump and motor, and pipeline distribution network.**
12. Estimated cost of works **\$200,000.00**
13. Estimated time required to construct works **One year**
14. Estimated time required to complete the application of water to beneficial use **Three years**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 62977 is issued subject to the terms and conditions imposed in said Permit 62977 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

This temporary permit is issued subject to the "Pipeline Gold Project Groundwater and Surface Water Monitoring Plan" submitted to the State Engineer on August 2, 1993.

Monthly records will be kept of the volume of water pumped from this well and delivered to the irrigation system under Temporary Permits 66217-T through 66220-T, inclusive. These records shall be submitted on the monthly report for Cortez Joint Venture.

The total combined duty of water under Permits 62977, 62978, 63168, 63169, and Temporary Permits 66217-T through 66220-T, inclusive, shall not exceed 2,415.48 acre-feet and is limited to the irrigation of 779.12 acres.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on **July 12, 2001** at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.9688 cubic feet per second, **but not to exceed 839.39 acre-feet per season, and not to exceed a seasonal duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.**

Work must be prosecuted with reasonable diligence and be completed on or before:


