The applicant **R. Barton Carl, Royce C. McDougal, James F. Davis & Kent Braden** hereby make application for permission to change the **Point of Diversion and Place of Use** of a **portion** of water heretofore appropriated under **Permit 19283, Certificate 6636**

1. The source of water is **Underground**
2. The amount of water to be changed **1.16 cfs, 281.14 Ac. Ft/Seas.**
3. The water to be used for **Irrigation**
4. The water heretofore permitted for **Irrigation**
5. The water is to be diverted at the following point **SW¼ SE¼, Sec. 10, T.24N., R.40E., MDB&M, or at a point from which the E¼ Corner of said Sec. 10 bears N 41° 34' 48" E, a distance of 3403.73 feet.**
6. The existing permitted point of diversion is located **SE¼ SE¼, Sec 10, T.24N, R.40E, MDB&M, or at a point from which the SE Corner of said Sec. 10 bears S 49° 59' 30" E, a distance of 86.75 feet.**
7. Proposed place of use **S½, Sec. 10, T.24N, R.40E, MDB&M Water will be comingled with other existing rights to irrigate a total of 316 acres.**
8. Existing place of use **Portions of the S½, sec. 10, T.24N., R.40E, MDB&M 205.4 acres.**
9. Use will be from **February 15 to November 15** of each year.
10. Use was permitted from **February 15 to November 15** of each year.
11. Description of proposed works **Well, pump and irrigation system**
12. Estimated cost of works **\$30,000.00**
13. Estimated time required to construct works **2 years**
14. Estimated time required to complete the application of water to beneficial use **5 years**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 19283, Certificate 6636, is issued subject to the terms and conditions imposed in said Permit 19283, Certificate 6636, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 19283, 23696, 66279 and 66280 shall not exceed 1264 acre-feet per season for the irrigation of 316.0 acres within the described place of use.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.16 cubic feet per second, and not to exceed a seasonal duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:

March 7, 2004

Proof of completion of work shall be filed before:

April 7, 2004

Water must be placed to beneficial use on or before:

March 7, 2007

Proof of the application of water to beneficial use shall be filed on or before:

April 7, 2007

Map in support of proof of beneficial use shall be filed on or before:

April 7, 2007


