The applicant **Stephen H. and Nelgene H. Bourne Trustees of the S. H. Bourne 1994 Trust u/i/d/, November 16, 1994**, hereby make application for permission to change the **point of diversion, place of use and manner of use of a portion** of water heretofore appropriated under Permit 56047

1. The source of water is **underground**
2. The amount of water to be changed **2 acre-feet annually (0.0086 CFS)**
3. The water to be used for **irrigation and domestic purposes**
4. The water heretofore permitted for **quasi-municipal purposes**
5. The water is to be diverted at the following point **NW¹/₄ SW¹/₄, Section 31, T.12N., R.20E., M.D.M.**, or at a point from which the southwest corner of said Section 31 bears **S14°14'W** a distance of **2,305 feet**.
6. The existing permitted point of diversion is located within **NE¹/₄ NE¹/₄, Section 33, T.14N., R.20E., M.D.M.**, or at a point from which the N¹/₄ corner of said Section 33 bears **N68°38'W** a distance of **2,676 feet**.
7. Proposed place of use **a portion of the N¹/₂ SW¹/₄ of Section 31, T.12N., R.20E., M.D.M.**, and a portion of the **NE¹/₄ SE¹/₄ of Section 36, T.12N., R.19E., M.D.M., Douglas County, Nevada**
8. Existing place of use **see attached sheet**
9. Use will be from **January 1st to December 31st** of each year.
10. Use was permitted from **January 1st to December 31st** of each year.
11. Description of proposed works **drilled well, pump, motor, and irrigation system improvements**
12. Estimated cost of works **\$10,000**
13. Estimated time required to construct works **two (2) years**
14. Estimated time required to complete the application of water to beneficial use **five (5) years**
15. Remarks: **The combined annual duty of this application together with accompanying applications for the Applicant shall be 8.0 acre feet annually as deeded by A.C. Houston Lumber Company, LLC. Water from this source shall be commingled with the Applicant's statutory allowance of 1,800 GPD/residence to meet domestic demands and irrigate their properties.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 56047 is issued subject to the terms and conditions imposed in said Permit 56047 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 66388, 66389, 66390 and 66391 shall not exceed 8.0 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Permits 66388, 66389, 66390 and 66391 are limited to the irrigation of 2.0 acres within the described place of use.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0086 cubic feet per second, but not to exceed 2.0 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:

April 26, 2003

Proof of completion of work shall be filed before:

May 26, 2003

Water must be placed to beneficial use on or before:

April 26, 2006

Proof of the application of water to beneficial use shall be filed on or before:

May 26, 2006

Map in support of proof of beneficial use shall be filed on or before:

May 26, 2006




