The applicant **DOUGLAS COUNTY**, hereby makes application for permission to change the **POINT OF DIVERSION AND PLACE OF USE** of water heretofore appropriated under **PERMIT 57924**

1. The source of water is **LAKE TAHOE (OLD SKYLAND INTAKE)**
2. The amount of water to be changed **0.0008 cfs (0.066 mga)**
3. The water to be used for **QUASI-MUNICIPAL (NO CHANGE)**
4. The water heretofore permitted for **QUASI-MUNICIPAL**
5. The water is to be diverted at the following point **AT A POINT FROM WHICH THE SOUTH ¼ CORNER OF SECTION 34, T14N, R18E, M.D.B. & M., BEARS S 38° 22' 43" E, A DISTANCE OF 5227.39 FEET. THE POINT OF DIVERSION IS IN LAKE TAHOE AND A PUBLIC SURVEY OF THE SECTIONAL BREAKDOWN OF THE LAKE IS NOT AVAILABLE.**
6. The existing permitted point of diversion is located within **AT A POINT FROM WHICH THE MEANDER CORNER BETWEEN SECTION 3, T13N, R18E, AND SECTION 34, T14N, R18E, M.D.B. & M., BEARS N 32° 27' 10" E, A DISTANCE OF 2470.25 FEET. THE POINT OF DIVERSION IS IN LAKE TAHOE AND A PUBLIC SURVEY OF THE SECTIONAL BREAKDOWN OF THE LAKE IS NOT AVAILABLE.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of Lake Tahoe heretofore granted under Permit 57924 is issued subject to the terms and conditions imposed in said Permit 57924 and with the understanding that no other rights at the source shall be affected by the change proposed herein. A totalizing meter must be installed in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to a beneficial use. This permit is subject to the final allocation of the State of Nevada under the California-Nevada-Interstate Compact Commission or any subsequent allocation approved by both states. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 60901, 60902, 60903, 60904, 60905, 60906, 60907, 60908, 60909, 66432, 66433, and 66434 shall not exceed 154.657 million gallons annually.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0008 cubic feet per second, **but not to exceed 0.066 million gallons annually.**

Work must be prosecuted with reasonable diligence and be completed on or before:

October 16, 2001

Proof of completion of work shall be filed before:

November 16, 2001

Water must be placed to beneficial use on or before:

October 16, 2003

Proof of the application of water to beneficial use shall be filed on or before:

November 16, 2003

Map in support of proof of beneficial use shall be filed on or before:
