The applicant **Michael B. Stewart**, hereby makes application for permission to change the **Point of Diversion, Manner & Place of Use of a Portion** of water heretofore appropriated under **Permit 51551**

1. The source of water is **Underground (Well #17)**
2. The amount of water to be changed **1.08 not to exceed 352.16 Acre-feet**
3. The water to be used for **Irrigation**
4. The water heretofore permitted for **Irrigation and Domestic**
5. The water is to be diverted at the following point **Lot 6, Section 1, T.35N., R.23E., M.D.B.&M., or at a point from which the NW corner of Section 11, said township and range, bears S. 51° 23' 36" W., a distance of 6809.95 feet.**
6. The existing permitted point of diversion is located within **NW¼ NW¼ Section 12, T.35N., R.23E., M.D.B.&M., or at a point from which the NW corner of said Section 12, bears N. 45° 00' W., a distance of 75 feet.**
7. Proposed place of use **Lots 2, 3, 5 through 13, inclusive, S½, Section 1; All Section 2; T.35N., R.23E., M.D.B.&M.; S½, E½ NW¼, NE¼, Section 36, T.36N., R.23E., M.D.B.&M.. 956.18 Acres total within the above described place of use.**
8. Existing place of use **S½, Lots 6 through 13, inclusive, Section 1, T.35N., R.23E., M.D.B.&M. The entire place of use is being changed.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Drilled well, 540 feet deep with a 14" casing equipped with a motor, pump, meter & distribution system.**
12. Estimated cost of works **Completed under Permit 62251**
13. Estimated time required to construct works **Completed under Permit 62251**
14. Estimated time required to complete the application of water to beneficial use **Five (5) Years**
15. Remarks: **The total combined duty of this application and applications to change a portion of Permit 51551 and all of Permits 53713 & 62247 is not to exceed 2592.72 Acre-feet.**

The total combined duty of this application and applications to change a portion of Permit 51551, and all of Permits 53713, 62247, 62251 & 62329 is not to exceed 3824.72 Acre-feet. Use map under Permit 51550 for existing Place of Use and Point of Diversion.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, manner of use and place of use of a portion of the waters of an underground source as heretofore granted under Permit 51551, is issued subject to the terms and conditions imposed in said Permit 51551, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the Proof of Completion of Work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 66597 through 66602, inclusive, shall not exceed 3,824.72 acre-feet annually for the irrigation of 956.18 acres.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.08 cubic feet per second, but not to exceed 352.16 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:
