The applicant **Robert D. Stitser** hereby makes application for permission to change the **point of diversion and place of use** of water heretofore appropriated under **Permit 61805**

1. The source of water is **underground**
2. The amount of water to be changed **0.1665 cfs**
3. The water to be used for **irrigation**
4. The water heretofore permitted for **irrigation**
5. The water is to be diverted at the following point **within the NW¼ NW¼ of Section 15, T.35 N., R.37E., MDB&M or at a point from which the N¼ corner of said Section 15 bears N 58° 47' E 2151.0 feet**
6. The existing permitted point of diversion is located **within the SE¼ SE¼ of Section 7, T. 35N., R.37E., MDB&M or at a point from which the SE corner of said Section 7 bears S 26° E 287.23 feet**
7. Proposed place of use **34.37 acres lying within portions of the NW¼ NW¼ and NE¼ NW¼ of Section 15, T.35N., R.37E., MDB&M**
8. Existing place of use **34.37 acres lying within the S½ SE¼ of Section 7, T.35N., R.37E., MDB&M**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **drilled well and irrigation system**
12. Estimated cost of works **in excess of \$20,000**
13. Estimated time required to construct works **3 years**
14. Estimated time required to complete the application of water to beneficial use **5 years**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 61805 is issued subject to the terms and conditions imposed in said Permit 61805 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 66647, 66648 and 66649 shall not exceed 137.48 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.1665 cubic feet per second, but not to exceed 45.827 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:

August 9, 2004

Proof of completion of work shall be filed before:

September 9, 2004

Water must be placed to beneficial use on or before:

August 9, 2006

Proof of the application of water to beneficial use shall be filed on or before:

September 9, 2006

Map in support of proof of beneficial use shall be filed on or before:


