The applicant **Michael B. Stewart**, hereby makes application for permission to change the **Point of Diversion, Manner and Place of Use** of water heretofore appropriated under **Permit 27270, Certificate 8920**

1. The source of water is **Underground (Well #19)**
2. The amount of water to be changed **2.0 c.f.s., not to exceed 1447.94 acre-feet**
3. The water to be used for **Irrigation**
4. The water heretofore permitted for **Irrigation and Domestic**
5. The water is to be diverted at the following point **NW¼ NE¼, Section 24, T.35N., R.23E., M.D.B.&M., or at a point from which the E¼ corner of Section 25, said township and range, bears S. 11°23'31" E., a distance of 6761.97 feet.**
6. The existing permitted point of diversion is located within **NE¼ NW¼, Section 24, T.35N., R.23E., M.D.B.&M., or at a point from which the N¼ corner of said Section 24 bears N. 24°14' E., a distance of 37.5 feet.**
7. Proposed place of use **N½ Section 24, T.35N., R.23E., M.D.B.&M., NW¼, Section 19, T.35N., R.24E., M.D.B.&M., 464.40 acres within the above described place of use.**
8. Existing place of use **39 ac. NW¼ NW¼, 36 ac. NE¼ NW¼, 39 ac. SW¼ NW¼, 40 ac. SE¼ NW¼, 39 ac. NW¼ NE¼, 40 ac. NE¼ NE¼, 80 ac. S½ NE¼, Section 24, T.35N., R.23E., M.D.B.&M.; 35 ac. NW¼ NW¼ (Lot 1), 35 ac. SW¼ NW¼ (Lot 2), 80 ac. E½ NW¼, Section 19, T.35N., R.24E., M.D.B.&M., 463 acres total.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Drilled well, equipped with a motor, pump, meter & distribution system.**
12. Estimated cost of works **\$50,000.00**
13. Estimated time required to construct works **One (1) Year**
14. Estimated time required to complete the application of water to beneficial use **Five (5) Years**
15. Remarks: **The total combined duty of this application and applications to change Permits 13781, 15153 and 23519 is not to exceed 1857.6 acre-feet. Use map on file under Permit 27270 for existing Point of Diversion and Place of Use.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place of use and manner of use of the waters of an underground source as heretofore granted under Permit 27270, Certificate 8920, is issued subject to the terms and conditions imposed in said Permit 27270, Certificate 8920, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the Proof of Completion of Work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 66704, 66705, 66706, and 66707 shall not exceed 1,857.6 acre-feet annually for the irrigation of 464.4 acres within the described place of use.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.0 cubic feet per second, **but not to exceed 1,447.94 acre-feet annually under this permit, and not to exceed an annual duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.**

Work must be prosecuted with reasonable diligence and be completed on or before:

May 11, 2003

Proof of completion of work shall be filed before:

June 11, 2003

Water must be placed to beneficial use on or before:

May 11, 2006

Proof of the application of water to beneficial use shall be filed on or before:

June 11, 2006


