The applicant **Charles M. & Arlene J. Muratore**, hereby make application for permission to change the **Point of Diversion and Place of Use** of water heretofore appropriated under **Permit 21341, Certificate 7132**

1. The source of water is **Underground**
2. The amount of water to be changed **2.5 c.f.s.**
3. The water to be used for **Irrigation and Domestic**
4. The water heretofore permitted for **Irrigation and Domestic**
5. The water is to be diverted at the following point **SE $\frac{1}{4}$ NW $\frac{1}{4}$, Sec. 7, T.44N, R.34E, MDB&M or at a point from which the SE Corner of said Sec. 7 bears S 45° 32' 21" E, a distance of 3,897 feet.**
6. The existing permitted point of diversion is located within **NW $\frac{1}{4}$ NW $\frac{1}{4}$, Sec. 7, T.44N, R.34E, MDB&M or at a point from which the NW Corner of said Sec. 7 bears N 40° 31' 40" W, a distance of 81.2 feet.**
7. Proposed place of use **295.6 acres in the NE $\frac{1}{4}$, N $\frac{1}{2}$ SE $\frac{1}{4}$, and portions of the S $\frac{1}{2}$ SE $\frac{1}{4}$, Sec. 7, T.44N, R.34E, MDB&M**
8. Existing place of use **160 acres in the NE $\frac{1}{4}$, Sec. 7, T.44N, R.34E, MDB&M**
9. Use will be from **April 1 to October 31** of each year.
10. Use was permitted from **April 1 to October 31** of each year.
11. Description of proposed works **Well, pump and irrigation system**
12. Estimated cost of works **\$40,000.00**
13. Estimated time required to construct works **2 years**
14. Estimated time required to complete the application of water to beneficial use **5 years**
15. Remarks: **Water will be comingled with other existing permits**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 21341, Certificate 7132, is issued subject to the terms and conditions imposed in said Permit 21341, Certificate 7132, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 16375, Certificate 7687; 16376, Certificate 7537; 21342, Certificate 7133; and Permits 66851, and 66852 shall not exceed 2,479.6 acre-feet per season.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 2.5 cubic feet per second, but not to exceed 640.0 acre-feet per season, and not to exceed a seasonal duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:

September 21, 2003

Proof of completion of work shall be filed before:

October 21, 2003

Water must be placed to beneficial use on or before:

September 21, 2005

Proof of the application of water to beneficial use shall be filed on or before:

October 21, 2005


