The applicant **Frade Ranches Inc.** hereby makes application for permission to change the **Point of Diversion of a Portion** of water heretofore appropriated under **50669**

1. The source of water is **Underground**
2. The amount of water to be changed **0.04 cfs**
3. The water to be used for **Irrigation & Domestic**
4. The water heretofore permitted for **Irrigation & Domestic**
5. The water is to be diverted at the following point **NW¼, SE¼ Section 18, T13N., R26E., M.D.M. or at a point from which the E¼ corner of said Section 18 Bears N 75° 25' 45" E a distance of 2,644.02 feet.**
6. The existing permitted point of diversion is located within **SW¼ NE¼ of Section 18 T13N., R26E., M.D.M. from which point the North ¼ corner of said Section 18 Bears N. 17° 15' 54" W., 2,268.87 Feet.**
7. Proposed place of use **SE¼, NE¼, Section 18, T13N., R26E., M.D.M. consisting of 3.4 acres.**
8. Existing place of use **SE¼, NE¼, Section 18, T13N., R26E., M.D.M. Consisting of 3.4 Acres**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Ditches & Pipes**
12. Estimated cost of works **\$5,000.00**
13. Estimated time required to construct works **2 years**
14. Estimated time required to complete the application of water to beneficial use **3 Years**

15. Remarks: Water will be used in conjunction with the system under permits No. 25633, 36924 and 48616 to provide better and more efficient irrigation of crops and pastures.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of a portion of the waters of an underground source as heretofore granted under Permit 50669, is issued subject to the terms and conditions imposed in said Permit 50669, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 66897, 66898, 66899, 66900, 25633, Certificate 8934; and 48616, Certificate 11881, and any waters of the Walker River Decree and any storage water appurtenant to the place of use shall not exceed 2,289.20 acre-feet per year for the irrigation of 572.3 acres. The permittee is responsible for insuring delivery of the entitled decreed and storage waters that are supplemental to these permits.

The issuance of Permits 66899 and 66900 abrogates Permit 50669.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.04 cubic feet per second, **but not to exceed 13.6 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.**

Work must be prosecuted with reasonable diligence and be completed on or before:

August 17, 2002

Proof of completion of work shall be filed before:

September 17, 2002

Water must be placed to beneficial use on or before:

August 17, 2006

Proof of the application of water to beneficial use shall be filed on or before:

September 17, 2006


