The applicant **Washoe County**, a political subdivision of the State of Nevada, hereby makes application for permission to change the Point of Diversion, Place of Use, and Manner of Use of a portion of water heretofore appropriated under **Permit 64048**

1. The source of water is **Howard's Creek, the North Branch of White's Creek**
2. The amount of water to be changed **0.61 cfs; 100.0afa**
3. The water to be used for **Golf Course Irrigation**
4. The water heretofore permitted for **Storage**
5. The water is to be diverted at the following point **NW $\frac{1}{4}$ SE $\frac{1}{4}$ Section 19, T.18N., R.20E., M.D.B. & M., or at a point from which the SE corner of said section 19 bears S. 33°03'13" E., a distance of 2,514.0 feet.**
6. The existing permitted point of diversion is located within **NE $\frac{1}{4}$ SE $\frac{1}{4}$ Section 17, T.18N., R.20E., M.D.B. & M., or at a point from which the NW corner of Section 8, T.18N., R.20E., M.D.B. & M., bears N. 31°33'26" W., a distance of 9,822.07 feet.**
7. Proposed place of use **E $\frac{1}{2}$ of Section 19 and E $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 19, all in T.18N., R.20E., M.D.B. & M.**
8. Existing place of use **N/A - primary storage permit, no place of use identified.**
9. Use will be from **January 1, 2001 to December 31, 2001** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Existing diversion structure on White's creek; pump, Pipeline, and pond.**
12. Estimated cost of works **\$500,000.00**
13. Estimated time required to construct works **N/A - Temporary**
14. Estimated time required to complete the application of water to beneficial use **N/A - Temporary**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the point of diversion, place of use and manner of use of a portion of the waters of Howard's Creek as heretofore granted under Permit 64048, which changed the point of diversion of Permit 62488, which changed the point of diversion, place of use and manner of use of a portion of Permit 41662, which changed the place of use and manner of use of a portion of Claim 716, Truckee River Decree is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein. A totalizing meter must be installed and accurate measurements of the water placed to beneficial use must be kept.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 64048 S-1 and 67012-T, shall not exceed 330 acre-feet annually.

This temporary permit is issued subject to the permittee compensating for any head loss, if any, of the other Howard's Creek users due to this permit and also subject to the continuing jurisdiction and regulation by the Federal Water Master.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on **December 31, 2001** at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.61 cubic feet per second, but not to exceed 100 acre-feet as decreed.
