The applicant **PATRICK RYLE, dba. SWEETWATER PLUMBING** hereby makes application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **Underground**

5. The water is to be diverted from its source at the following point **Located in the SE $\frac{1}{4}$ -SW $\frac{1}{4}$ of Section 26, T.19 N., R.28 E., M.D.B.& M., from a point that bears S 76°14'00" W a distance of 1969.00 feet to the SW corner of said Section 26.**
6. Place of Use **a portion of the SE $\frac{1}{4}$ -SW $\frac{1}{4}$ of Section 26, T.19 N., R.28 E., M.D.B.& M., a total of 1.08 acres.**
7. Use will begin about **JAN 1** and end about **DEC 31** of each year.
8. Description of proposed works **Drilled Well, Pump, Storage Tank & and Distribution System**
9. Estimated cost of works **\$25,000**
10. Estimated time required to construct works **2 year**
11. Estimated time required to complete the application of water to beneficial use **4 years**

12. Remarks: Application is for a commercial plumbing business to support an office/maintenance building, storage yard and incidental uses such as dust control and landscaping with a consumptive rate not to exceed 2,000 G.P.D., or 0.73 million gallons per year.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level. This well shall be equipped with a two (2) inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. This source is located within an area designated by the State Engineer, pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This permit is issued under the provisions of NRS 534.120(2) as a preferred use.

Any well drilled under this permit shall be drilled in what has been described in the United States Geological Survey Water Supply Paper 2263 as the intermediate alluvial aquifer. In no instance shall the seal on this well be less than 100 feet below ground level.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.25 cubic feet per second, but not to exceed 2.24 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before:

September 17, 2003

Proof of completion of work shall be filed before:

October 17, 2003

Water must be placed to beneficial use on or before:

September 17, 2005

Proof of the application of water to beneficial use shall be filed on or before:

October 17, 2005


