The applicant **Dry Lake Water Company, LLC**, hereby makes application for permission to change the **point of diversion of a portion**, of water heretofore appropriated under **Permit 66163**

1. The source of water is **underground**
2. The amount of water to be changed **1.175 cfs and 348 afa**
3. The water to be used for **quasi-municipal**
4. The water heretofore permitted for **quasi-municipal**
5. The water is to be diverted at the following point **within the NE¼ NE¼ Sec 13 T19S R63E MDBM**
6. The existing permitted point of diversion is located within **SW¼ NW¼ of Sec 18 T19S R64E MDBM at a point that bears N 18 28' W at a distance of 2085.0 ft to the NW corner of said Sec. 18.**
7. Proposed place of use **see exhibit A**
8. Existing place of use **see exhibit A**
9. Use will be from **Jan 1 to Dec 31** of each year.
10. Use was permitted from **Jan 1 to Dec 31** of each year.
11. Description of proposed works **drilled well casing submersible pump and motor. Distribution system to place of use.**
12. Estimated cost of works **\$950,000**
13. Estimated time required to construct works **3 years**
14. Estimated time required to complete the application of water to beneficial use **10 years**
15. Remarks: **This is a Temporary Application. Water to be used within Apex Industrial Park. Refer to map under file 64547 and attached plat.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions.

This temporary permit to change the point of diversion of a portion of the waters of an underground source as heretofore granted under Permit 66163 is issued subject to the terms and conditions imposed in said Permit 66163 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

The total combined duty of water under Temporary Permits 67139-T, 67140-T, 67141-T and Permits 66163, 66164, 66165 and 66166 shall not exceed 1,392.06 acre-feet annually.

Prior to any pumping under this permit, a dedicated monitoring well to measure the static water level shall be placed in a location approved by the State Engineer which will determine impacts to existing rights.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on **April 8, 2002** at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.175 cubic feet per second, **but not to exceed 348 acre feet annually.**


