The applicant **Sandra E. Evenson and Dennis J. Evenson** hereby make application for permission to change the **Point of Diversion and Place of Use** of water heretofore appropriated under **Permit 64830**

1. The source of water is **an underground source**
2. The amount of water to be changed **0.04 CFS not to exceed 6.0 acre-feet annually**
3. The water to be used for **Irrigation and Domestic (no change)**
4. The water heretofore permitted for **Irrigation and Domestic**
5. The water is to be diverted at the following point **within the SE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 10, T13N, R19E, MDB&M or at a point from which the NW corner of said Section 10 bears N 33° 59' W, 2649 feet.**
6. The existing permitted point of diversion is located within **the NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 10, T12N, R19E, MDB&M or at a point from which the south $\frac{1}{4}$ corner of said Section 10 bears S 00° 31' 46" W, 1733.4 feet**
7. Proposed place of use **1.5 acres within Lot 17 in Pioneer Trail Ranch Subdivision No 2 in the SE $\frac{1}{4}$ NW $\frac{1}{4}$ and the N $\frac{1}{2}$ SW $\frac{1}{4}$ of Section 10, T13N, R19E, MDB&M, Douglas County, Nevada**
8. Existing place of use **1.5 acres within the S $\frac{1}{2}$ SE $\frac{1}{4}$ of Section 9, T12N, R19E, MDB&M, Douglas County, Nevada**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Well, pump and motor, storage tank and irrigation distribution system.**
12. Estimated cost of works **\$15,000**
13. Estimated time required to construct works **1 Year**
14. Estimated time required to complete the application of water to beneficial use **5 Years**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 64830, is issued subject to the terms and conditions imposed in said Permit 64830, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.04 cubic feet per second, but not to exceed 6.0 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:

August 10, 2002

Proof of completion of work shall be filed before:

September 10, 2002

Water must be placed to beneficial use on or before:

August 10, 2003

Proof of the application of water to beneficial use shall be filed on or before:

September 10, 2003


