The applicant **Operating Engineers and Participating Employers Pre-apprentice, Apprentice and Journeyman Affirmative Action Training Fund** hereby makes application for permission to change the **manner of use** of water heretofore appropriated under **Permit 49412**

1. The source of water is **underground.**
2. The amount of water to be changed **.1 cfs and 23.59 mga (72.39 afa)**
3. The water to be used for **commercial and domestic**
4. The water heretofore permitted for **mining, milling and domestic.**
5. The water is to be diverted at the following point **NW¼ NE¼ Sec. 13, T20N, R23E, MDM, or at a point from which the N¼ corner of said Section 13 bears N 87° 26' W a distance of 930 feet.**
6. The existing permitted point of diversion is located within
7. Proposed place of use **NW¼ NE¼, NE¼ NE¼, SW¼ NE¼ and portion of SE¼ NE¼ lying north of the northerly right-of-way line of Interstate 80, Sec. 13, T20N, R23E, MDM.**
8. Existing place of use **NW¼ NE¼, NE¼ NE¼, SW¼ NE¼ and portion of SE¼ NE¼ lying north of the northerly right-of-way line of Interstate 80, Sec. 13, T20N, R23E, MDM.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Drilled well, pump and motor and distribution system.**
12. Estimated cost of works **\$50,000**
13. Estimated time required to construct works **Three years. Existing well may need to be replaced.**
14. Estimated time required to complete the application of water to beneficial use **Six years.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the manner of use of the waters of an underground source as heretofore granted under Permit 49412, is issued subject to the terms and conditions imposed in said Permit 49412, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 67196, 67197, and 67198, shall not exceed 212.0 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.1 cubic feet per second, but not to exceed 72.39 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before:

September 21, 2002

Proof of completion of work shall be filed before:

October 21, 2002

Water must be placed to beneficial use on or before:

September 21, 2003

Proof of the application of water to beneficial use shall be filed on or before:

October 21, 2003

Map in support of proof of beneficial use shall be filed on or before:
