The applicant Nye County hereby makes application for permission to change the Point of Diversion, Manner of Use and Place of Use of a portion of water heretofore appropriated under Permit 64425

- 1. The source of water is an underground source in Pahrump Regional Planning Dist., Nye County, Nv
2. The amount of water to be changed 3.5 AFA., not to exceed 0.0115 CFS.
3. The water to be used for Municipal
4. The water heretofore permitted for Irrigation and Domestic purposes
5. The water is to be diverted at the following point within the NE.1/4 NW.1/4 of Section 15, T.20S., R.53E., M.D.M., or at a point from which the N. 1/4 corner of said Section 15, bears N. 84° 24' 00" e., a distance of 660.81 feet
6. The existing permitted point of diversion is located within the SE.1/4 SW.1/4 of Section 31, T.21S., R.54E., M.D.M., or at a point from which the S. 1/4 corner of said Section 31 bears S 03° 09' 11" E., a distance of 911.33 feet
7. Proposed place of use Pahrump Regional Planning District, being all of Township 18, 19, 20, & 21 South, Range 52 East; Township 18, 19, 20, 21, & 22 South, Range 53 East; and those portions of Township 18, 19, 20, 21 & 22 South, Range 54 East lying within Nye County
8. Existing place of use 0.70 acres within E.1/2 SW.1/4 of Section 31, T.21S., R. 54 E., M.D.M., Nye County, Nv, being Lots 40 and 41 of Cal-Vista Subdivision, File 17521, Nye County Records
9. Use will be from January 1 to December 31 of each year.
10. Use was permitted from January 1 to December 31 of each year.
11. Description of proposed works An 8" diameter ground water well, with steel casing all the way
12. Estimated cost of works not known
13. Estimated time required to construct works presently completed
14. Estimated time required to complete the application of water to beneficial use 10 years
15. Remarks: Water rights are being transferred in association with Parcel Map Application

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion, place and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 64425, is issued subject to the terms and conditions imposed in said Permit 64425, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

If any water under this permit is cancelled, withdrawn, or any water is not put to beneficial use, it will revert to the groundwater source and not back to the base water right.

This permit is issued with the understanding that three new residential parcels for single family dwellings are being created by the dedication of this water right. This permit is limited to the service of three parcels created from Assessor's Parcel No. 35-543-04.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0115 cubic feet per second, **but not to exceed 3.5 acre-feet annually.**


