1. The source of the proposed appropriation is **Underground – Osborne**
2. The amount of water applied for is **2.7 c.f.s., 640 AFA** second-feet
 - (a) If stored in reservoir give number of acre-feet
3. The water to be used for **Irrigation and Domestic**
4. If use is for:

7. Use will begin about **January 1** and end about **December 31** of each year.

11. Estimated time required to complete the application of water to beneficial use **5 years**
