The applicant **Boomtown, Inc.** hereby make application for permission to change the **Point of Diversion & Place of Use of a portion** of water heretofore appropriated under **Claim No. 94/94a of the Truckee River Decree, said Decree entered by the District Court of the United States in and for the District of Nevada in that certain action entitled "The United States of America, Plaintiff vs. Orr Ditch Water Company, Etal, Defendants," in Equity Docket No. A-3**

1. The source of water is **Truckee River**
2. The amount of water to be changed **0.041 c.f.s. – 4.14 acre feet annually**
3. The water to be used for **As Decreed**
4. The water heretofore permitted for **As Decreed**
5. The water is to be diverted at the following point **NE SW of Section 31 T19N, R18E, MDM, or at a point from which the SW corner of Section 32 T19N, R18E, MDM, bears S 62° 04' 00" E, a distance of 3195.00 feet. (Steamboat Canal)**
6. The existing permitted point of diversion is located within the **SE NE of Section 30 T19N, R18E, MDM, or at a point from which the NW corner of Section 29 T19N, R18E, MDM, bears N 08° 33' 00" E, a distance of 1520.00 feet. (Coldron Ditch)**
7. Proposed place of use **Within portions of Sections 16 and 17 T19N, R18E, MDM**
8. Existing place of use **0.92 acres in the NE NE of Section 17 T19N, R18E, MDM**
9. Use will be from **As Decreed to As Decreed of each year.**
10. Use was permitted from **As Decreed to As Decreed of each year.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of the Truckee River as heretofore granted under Claims 94/94A, Truckee River Final Decree is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein. A suitable measuring device must be installed and accurate measurements of water placed to beneficial use must be kept.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This permit is limited to the irrigation of 0.92 acres within the described place of use and not to exceed an annual duty of 4.50 acre-feet per acre of land irrigated from any and/or all sources. This period of use is as decreed.

The amount of water to be changed shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.041 cubic feet per second, **but not to exceed 4.14 acre-feet as decreed.**

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

December 1, 2007

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:

December 1, 2011

Map in support of proof of beneficial use shall be filed on or before:


