The applicant **Tehama Holdings, Inc.** hereby makes application for permission to change the **Place of Use** of water heretofore appropriated under **all of Permit No. 58509, Certificate No. 14044**

1. The source of water is **underground (MCO Well #2)**
2. The amount of water to be changed **0.008 cfs, 2.60 acre feet annually**
3. The water to be used for **Irrigation and Domestic**
4. The water heretofore permitted for **Irrigation and Domestic**
5. The water is to be diverted at the following point **within the NE¼ of the NW¼ of Section 5, T.22N., R.21E., M.D.M., or at a point from which the northeast corner of said Section 5 bears North 66° 17' 59" East a distance of 2969.86 feet. See Map to Accompany Proof of Beneficial Use under Permit Nos. 57084, 57085, 57086, 57087, 57088, 57089, 57090, 57091, 57093, 57094, 57095, 58507, 58508 and 58509.**
6. The existing permitted point of diversion is located within **(P.O.D. is not changed.)**
7. Proposed place of use **110.81 acres within the SE¼ of the NW¼, NE¼ of the SW¼ & SE¼ of the SW¼ of Section 4 and the NE¼ of the NW¼ of Section 9; all in T.22N., R.21E., M.D.M.. Washoe County Assessor's Parcel Nos. 77-340-05 and 77-340-45. See attached Assessor's map.**
8. Existing place of use **0.37 acres within the NE¼ of the NE¼ of Section 5 and 0.28 acres within the NW¼ of the NE¼ of Section 5, T22N., R.21E., M.D.M.. Washoe County Assessor's Parcel No. 77-090-13. See Map to Accompany Proof of Beneficial Use under Permit Nos. 57084, 57085, 57086, 57087, 57088, 57089, 57090, 57091, 57093, 57094, 57095, 58507, 58508 and 58509.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Existing well, pump and sprinkler irrigation system.**
12. Estimated cost of works **No additional expenses required.**
13. Estimated time required to construct works **Not applicable.**
14. Estimated time required to complete the application of water to beneficial use **1 year**
15. Remarks: **This water will be used to grow sod on a total of 40.0 acres within the designated place of use.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions.

This temporary permit to change the place of use of the waters of an underground source as heretofore granted under Permit 58509, Certificate 14044, is issued subject to the terms and conditions imposed in said Permit 58509, Certificate 14044, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is limited to the irrigation of 0.65 acres within the described place of use.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on **July 12, 2002** at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed **0.008** cubic feet per second, **but not to exceed 2.60 acre-feet annually, and not to exceed an annual duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.**

Work must be prosecuted with reasonable diligence and be completed on or before:


