The applicant **SILVER HILL ENERGY ASSOCIATES, LLC** hereby makes application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **underground**
2. The amount of water applied for is **5.0** second feet.
  - (a) If stored in reservoir give number of acre-feet
3. The water to be used for **industrial (power generation)**
4. If use is for:

  - (b) Stockwater, state number and kind of animals to be watered

  - (d) Power:
    - (1) Horsepower developed
    - (2) Point of return of water to stream
5. The water is to be diverted from its source at the following point **SW $\frac{1}{4}$  NW $\frac{1}{4}$  Sec. 13, T27N, R31E, M.D.M.; or at a point from which the SE corner of Sec. 18, T27N, R32E, M.D.M., bears S 73° 09' 54" E a distance of 10,353 feet.**
6. Place of Use **See "Exhibit A"**
7. Use will begin about **January 1** and end about **December 31** of each year.
8. Description of proposed works **Drilled, cased well with electrical pump and distribution system to place of use**
9. Estimated cost of works **\$175,000**
10. Estimated time required to construct works **four years**
11. Estimated time required to complete the application of water to beneficial use **seven years**
