The applicant **Bright-Holland Corporation, a Nevada Corporation**, hereby makes application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **Underground**
2. The amount of water applied for is **3.0 cfs second-feet**
  - (a) If stored in reservoir give number of acre-feet
3. The water to be used for **Irrigation Purposes**
4. If use is for:
  - (a) Irrigation, state number of acres to be irrigated **400 Acres**
  - (b) Stockwater, state number and kinds of animals to be watered
  - (c) Other use (describe fully under No. 12. "Remarks")
  - (d) Power:
    - (1) Horsepower developed
    - (2) Point of return of water to stream
5. The water is to be diverted from its source at the following point **NE $\frac{1}{4}$  NW $\frac{1}{4}$  Section 5, T.30N., R.19E., M.D.B.&M., or at a point from which the NE corner of said Section 5 bears N. 82° 55' 00" E., a distance of 3025 feet**
6. 9. Estimated cost of works **\$100,000.00**
10. Estimated time required to construct works **Four (4) Years**
11. Estimated time required to complete the application of water to beneficial use **Six (6) Years**
