This temporary permit, to change the point of diversion, place of use and manner of use of the waters of Galena Creek as heretofore granted under Permit 25335, Certificate 8477, which changed the point of diversion and place of use of a portion of Claim No. 652 of the Truckee River Decree, is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein. A suitable measuring device must be installed and accurate measurements of water placed to beneficial use must be kept.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.
