1. The source of water is Cave Spring
2. The amount of water to be changed 0.0008 cfs or sufficient to water 25 horses
3. The water to be used for Wildlife Watering and Habitat Preservation Purposes
4. The water heretofore permitted for Stock Watering Purposes
5. The water is to be diverted at the following point w/in SE¼ SW¼ Section 6 T24S, R58E, MDM or at a point from which the SE corner of Section 17 T24S, R58E, MDM., bears S 38 degrees 48 minutes E, a distance of 14,126 feet

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the manner of use of the waters of Cave Spring as heretofore granted under Permit 10845, Certificate 3353, is issued subject to the terms and conditions imposed in said Permit 10845, Certificate 3353, and with the understanding that no other rights on the source will be affected by the change proposed herein.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0008 cubic feet per second, but not to exceed 0.56 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before:

April 17, 2003

Proof of completion of work shall be filed before:

May 17, 2003

Water must be placed to beneficial use on or before:

April 17, 2004

Proof of the application of water to beneficial use shall be filed on or before:

May 17, 2004

Map in support of proof of beneficial use shall be filed on or before:


