The applicant **Michael M. Winger and Cynthia Winger** hereby makes application for permission to change the **point of diversion and place of use of a portion of water heretofore appropriated under Permit #14468, Cert #6372**

1. The source of water is **underground source**
2. The amount of water to be changed **0.0014 C.F.S., One (1) Acre Foot.**
3. The water to be used for **quasi-municipal purposes**
4. The water heretofore permitted for **quasi-municipal purposes**
5. The water is to be diverted at the following point **within the Southeast Quarter (SE¼) of the Northwest Quarter (NW¼), Section 28, T20S, R62E, MDM, or at a point from which the center one quarter (C¼) of said Sec 28 T20S, R62E, MDM bears South 34° 44' 00" East a distance of 1386.0 Feet.**
6. The existing permitted point of diversion is located within a **portion of the Northwest Quarter (NW¼) of the Northwest Quarter (NW¼), Section 10, T21S, R61E, MDM or at a point from which the Northwest corner of said SEction 10, T21S, R61E, MDM bears North 15° 40' 00" West a distance of 917.0 Feet.**
7. Proposed place of use. **Lot 1 of Block 3, per Book 4 Page 10 of Plats, being a portion of the Southeast Quarter (SE¼) of the Northwest Quarter (NW¼), of Section 28, T20S, R62E, MDM, Assessor Parcel Number 140-28-211-006.**
8. Existing place of use **portion of the Northeast Quarter (NE¼) of the Northeast Quarter (NE¼), SEction 9, and a portion of the Northwest Quarter (NW¼) of the Northwest Quarter (NW¼), SEction 10, T21S, R61E, MDM.**
9. Use will be from **January 1st to December 31st** of each year.
10. Use was permitted from **January 1st to December 31st** of each year.
11. Description of proposed works **Install Totalizing Meter and appurtenances**
12. Estimated cost of works **\$1,500.00**
13. Estimated time required to construct works **Well is two hundred feet deep, steel cased, with 1½ Hp Submersible pump and pressure tanks.**
14. Estimated time required to complete the application of water to beneficial use **Three (3) Years**
15. Remarks: **Water to be used for an existing residence and landscaping.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 14468, Certificate 6372, is issued subject to the terms and conditions imposed in said Permit 14468, Certificate 6372, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Permit 67831 is granted to provide water service to one (1) lot described by Clark County Assessor's Parcel Number 140-28-211-006.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0014 cubic feet per second, but not to exceed 1.0 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before:

April 12, 2003

Proof of completion of work shall be filed before:

May 12, 2003

Water must be placed to beneficial use on or before:

April 12, 2005

Proof of the application of water to beneficial use shall be filed on or before:

May 12, 2005
