The applicant **Bently Family Limited Partnership** hereby makes application for permission to change the **Point of Diversion and Place of Use** of water heretofore appropriated under **Permit 65597**

1. The source of water is **and Underground Source**
2. The amount of water to be changed **0.67 cfs not to exceed 397.6 acre feet annually**
3. The water to be used for **Irrigation (no change)**
4. The water heretofore permitted for **Irrigation**
5. The water is to be diverted at the following point **within the SW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 20, T13N, R20E, MDB&M or at a point from which the NE corner of said Section 20 bears N 66° 57' E, 5225 feet**
6. The existing permitted point of diversion is located within the **NW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 3, T13N, R20E, MDB&M, or at a point from which the NE corner of said Section 3 bears N 28° 10' 23" E, a distance of 3102.24 feet**
7. Proposed place of use **117.4 acres within the SE $\frac{1}{4}$ S-4, SW $\frac{1}{4}$, W $\frac{1}{2}$ SE $\frac{1}{4}$ S-3, E $\frac{1}{2}$ S-9, W $\frac{1}{2}$, W $\frac{1}{2}$ E $\frac{1}{2}$ S-10, NE $\frac{1}{4}$, N $\frac{1}{2}$ SE $\frac{1}{4}$ S-16, NW $\frac{1}{4}$, W $\frac{1}{2}$ NE $\frac{1}{4}$, NE $\frac{1}{4}$ SE $\frac{1}{4}$ S-15, all in T13N, R20E, MDM, Douglas County, Nevada**
8. Existing place of use **117.4 acres within the SE $\frac{1}{4}$ of Section 4, SW $\frac{1}{4}$, W $\frac{1}{2}$ SE $\frac{1}{4}$ of Section 3, all in T13N, R20E, MDB&M, Douglas County, Nevada**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **drilled well, pump and motor, distribution lines and a sprinkler irrigation system**
12. Estimated cost of works **unknown at this time**
13. Estimated time required to construct works **2 years – well is completed and has a 16 inch casing – 380 feet deep**
14. Estimated time required to complete the application of water to beneficial use **10 years**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 65597, is issued subject to the terms and conditions imposed in said Permit 65597, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permits 67862, 67863, 67864, 67865, 67866, 67867 and 67868 shall not exceed 648.91 acre-feet annually for the irrigation of 162.93 acres within the described place of use.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.67 cubic feet per second, **but not to exceed 397.6 acre-feet annually, and not to exceed an annual duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.**

Work must be prosecuted with reasonable diligence and be completed on or before:




