Item 6. Proposed Place of Use:

Portions of Hydrographic Basins #204 (Clover Valley) and #205 (Meadow Valley Wash), and all of Hydrographic Basins #221 (Tule Desert) and #222 (Virgin Valley) in Lincoln County, Nevada. The proposed place of use includes:

Township 5 South through Township 12 South (including One-Half Townships) for the area covered by Range 67 East through Range 71 East. All within Lincoln County, Nevada.
