The applicant William Roy Clarno and Jeannie Clarno hereby make application for permission to change the Point of Diversion of a Portion of water heretofore appropriated under Permit 29823 - Certificate 9781

- 1. The source of water is an underground Source
2. The amount of water to be changed 1.123 cfs or 504 gpm
3. The water to be used for Irrigation (no change)
4. The water heretofore permitted for Irrigation
5. The water is to be diverted at the following point within the SW 1/4 of the NW 1/4 of Section 7, T38N, R37E, MDM or at a point from which the NW corner of said Section 7 bears N 00° 42' 02" W, 2173.52 feet
6. The existing permitted point of diversion is located within the NW 1/4 SE 1/4 of Section 7, T38N, R37E, MDM or at a point from which the SW corner of said Section 7 bears S 61° 27' W, a distance of 3135 feet.

15. Remarks: **Production from the three (3) wells covered under Permits 29823, 29829 & 29831 furnishing water to the four (4) pivot sprinklers in Section 7, T38N, R37E, MDM has dropped to the point another well is needed to furnish enough water to operate the four (4) pivots.**

The supporting map submitted with this Application uses a different basis of bearing than that used to support the Permit being changed and the ties are slightly different. However, the new ties and old ties are within 300 feet of each other and in the same Quarter - Quarter of the Section, therefore, the old ties are shown on this Application.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of a portion of the waters of an underground source as heretofore granted under Permit 29823, Certificate 9781, is issued subject to the terms and conditions imposed in said Permit 29823, Certificate 9781, and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 29823, 29829, 29831, 67999, 68000 and 68001 shall not exceed 1952.0 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

With the issuance of this permit, Temporary Permit 67749-T is expired.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.123 cubic feet per second, and not to exceed an annual duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:

March 7, 2003

Proof of completion of work shall be filed before:

April 7, 2003

Water must be placed to beneficial use on or before:

March 7, 2004

Proof of the application of water to beneficial use shall be filed on or before:

April 7, 2004

Map in support of proof of beneficial use shall be filed on or before:

April 7, 2004


