The applicant **Kennecott Nevada Copper Company** hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **underground**
2. The amount of water applied for is **5.0 cfs second-feet**
  - (a) If stored in reservoir give number of acre-feet
3. The water to be used for **industrial (power generation)**
4. If use is for:
  - (a) Irrigation, state number of acres to be irrigated
  - (b) Stockwater, state number and kinds of animals to be watered
  - (c) Other use (describe fully under No. 12. "Remarks")
  - (d) Power:
    - (1) Horsepower developed
    - (2) Point of return of water to stream
5. The water is to be diverted from its source at the following point **within the SW¼ NE¼ of Section 11 T18N R63E MDM, or at a point from which the NE corner of Section 34 T19N R64E MDM bears N 65 33' 52" E a distance of 30,683 feet**
6. Place of Use **Refer to attached Exhibit "A"**
7. Use will begin about **January 1** and end about **December 31** of each year.
8. Description of proposed works **Drilled and cased well, submersible pump and motor.**
9. Estimated cost of works **\$250,000**
10. Estimated time required to construct works **5 years**
11. Estimated time required to complete the application of water to beneficial use **10 years**

The water sought by this application will be utilized in conjunction with other surface and ground water rights utilized by the applicant.
