The applicant **Richard J. & Anne M. Luksza and ALSO Ray E. Mix & Deborah K. Mix**, hereby makes application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **UNDERGROUND**
2. The amount of water applied for is **0.1 second-feet**

5. The water is to be diverted from its source at the following point located within the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 15, Township 17 North, Range 63 East, M.D.B.&M. from which point the Northwest Corner of said Section 15 bears N. 47° 03' 50" W., 3,804.87 feet
6. Place of Use being a portion of the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 15, T.17N., R.63E., M.D.B.&M
7. Use will begin about **January 1st** and end about **December 31st** of each year.
8. Description of proposed works **Using the existing 16 inch diameter well and pumping the water to each residential household**
9. Estimated cost of works **Unknown**
10. Estimated time required to construct works **5 years, there is an existing 16 inch well.**
11. Estimated time required to complete the application of water to beneficial use **5 years**

12. Remarks: Two residence will pump water from the existing well and the water will be used for domestic use only

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level. This well shall be equipped with a two (2) inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. This source is located within an area designated by the State Engineer, pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This permit is issued under the provisions of NRS 534.120(2) as a preferred use.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.10 cubic feet per second, but not to exceed 0.73 million gallons annually.

Work must be prosecuted with reasonable diligence and be completed on or before:

January 27, 2004

Proof of completion of work shall be filed on or before:

February 27, 2004

Water must be placed to beneficial use on or before:

January 27, 2008

Proof of the application of water to beneficial use shall be filed on or before:

February 27, 2008

Map in support of proof of beneficial use shall be filed on or before:
