The applicant **Frances J. Fischer** hereby make application for permission to change the **Point of Diversion & Place of Use of an underground source** of water heretofore appropriated under **Permit No. 54616**

1. The source of water is **Underground**
2. The amount of water to be changed **Four (4) acre feet**
3. The water to be used for **Irrigation and Domestic Use**
4. The water heretofore permitted for **Irrigation and Domestic Use**
5. The water is to be diverted at the following point **SE¹/₄ of the NE¹/₄ of Section 14, T.23N., R.20E., M.D.M., at a point lying S 05°47'02" W, 1366.65 feet from the northeast quarter of said Section 14.**
6. The existing permitted point of diversion is located within the **NE¹/₄, NE¹/₄ Section 14, T23N, R20E, bearing South 9° West 1240 feet from the northeast corner of said Section 14.**
7. Proposed place of use **NE¹/₄ of the NW¹/₄ of Section 13, T.23N., R.20E., M.D.M., Washoe County, Nevada.**
8. Existing place of use **1.0 acre within the E¹/₂, NE¹/₄ Section 14, T23N, R20E, M.D.B.&M.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **drilled well with pump and electric motor.**
12. Estimated cost of works **\$20,000**
13. Estimated time required to construct works [completed] **constructed 8" well drilled 300' deep with 7½ HP pump and 23 KW diesel generator.**
14. Estimated time required to complete the application of water to beneficial use **1 year**
15. Remarks: **Permitted point of diversion is the NE¹/₄ of the NE¹/₄ of Section 14. By mistake, the well was actually drilled in the SE¹/₄ of the NE¹/₄ of Section 14.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 54616 is issued subject to the terms and conditions imposed in said Permit 54616 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This permit is issued for drip irrigation of discrete plantings within the described place of use. Reversion to a crop-type broadcast or flood irrigation regime shall limit the place of use to no more than 1.0 acres within the described place of use.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.00553 cubic feet per second, but not to exceed 4.0 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before:

October 3, 2004

Proof of completion of work shall be filed before:

November 3, 2004

Water must be placed to beneficial use on or before:

October 3, 2005

Proof of the application of water to beneficial use shall be filed on or before:

November 3, 2005

Map in support of proof of beneficial use shall be filed on or before:

November 3, 2005
