The applicant **William H. Norton, Jr. and Patricia A. Norton** hereby make application for permission to change the **Manner and Place of Use of a portion** of water heretofore appropriated under **Permit No. 22165, Certificate No. 8564**

1. The source of water is **Underground**
2. The amount of water to be changed **21.82 Acres, 87.28 Acre feet, 0.1224 cfs**
3. The water to be used for **Irrigation and Domestic**
4. The water heretofore permitted for **Irrigation**
5. The water is to be diverted at the following point **in the SW $\frac{1}{4}$  of SE $\frac{1}{4}$  of Section 32, T.21 $\frac{1}{2}$ N., R.54E., MDB&M., or at a point from which the S $\frac{1}{4}$  corner of Section 32 bears S. 60°56' W. a distance of 227.3 feet.**
6. The existing permitted point of diversion is located within **the SW $\frac{1}{4}$  of SE $\frac{1}{4}$  of Section 32, T.21 $\frac{1}{2}$ N., R.54E., MDB&M., or at a point from which the S $\frac{1}{4}$  corner of said Section 32 bears S. 60°56' W. a distance of 227.3 feet.**
7. Proposed place of use **Portions of NW $\frac{1}{4}$  of SE $\frac{1}{4}$ , SW $\frac{1}{4}$  of SE $\frac{1}{4}$ , NE $\frac{1}{4}$  of SW $\frac{1}{4}$ , and SE $\frac{1}{4}$  of SW $\frac{1}{4}$  of Section 32, T.21 $\frac{1}{2}$ N., R.54E., MDB&M. (21.82 acres). To be combined with two other applications of 35.00 acres and 11.00 acres for a pivot system. Total of 67.82 acres.**
8. Existing place of use **Portion of NW $\frac{1}{4}$  of SE $\frac{1}{4}$  (11.21 acres) and portion of SW $\frac{1}{4}$  of SE $\frac{1}{4}$  (10.61 acres) of Section 32, T.21 $\frac{1}{2}$ N. R.54E., MDB&M. Total of 21.82 acres.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **use of existing well with pump and pipe line to irrigation pivot.**
12. Estimated cost of works **\$20,000.00**
13. Estimated time required to construct works **2 years**
14. Estimated time required to complete the application of water to beneficial use **5 years**
15. Remarks: **This application is to be combined transfer of Permit No. 36062, Certificate No. 11248 and Permit No. 40012, Certificate No. 11251.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 22165, Certificate 8564 is issued subject to the terms and conditions imposed in said Permit 22165, Certificate 8564 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 68446, 68447 and 68448 shall not exceed 267.28 acre-feet annually.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Permits 68446, 68447 and 68448 are issued for the irrigation of 66.82 acres within the described place of use.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.1223 cubic feet per second, but not to exceed 87.28 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:

February 4, 2005

Proof of completion of work shall be filed on or before:

March 4, 2005

Water must be placed to beneficial use on or before:

February 4, 2006

Proof of the application of water to beneficial use shall be filed on or before:

March 4, 2006

Map in support of proof of beneficial use shall be filed on or before:


