The applicant **Jelindo Angelo Tiberti and Sandra Lee Melvin Tiberti**, hereby make application for permission to change the **point of diversion and place of use of a portion of water** heretofore appropriated under **Permit 24582, Certificate 7673**

1. The source of water is **underground source**
2. The amount of water to be changed **0.0066 C.F.S. 3 Acre Feet**
3. The water to be used for **quasi-municipal purposes**
4. The water heretofore permitted for **quasi-municipal purposes**
5. The water is to be diverted at the following point **within the southeast quarter (SE $\frac{1}{4}$) of the southwest quarter (SW $\frac{1}{4}$) of Sec 26, T21S, R60E, MDM or at a point from which the south one-quarter (S $\frac{1}{4}$) corner of said Sec 26, bears south 31°41'00" east a distance of 1177.0 feet.**
6. The existing permitted point of diversion is located within **the northwest quarter (NW $\frac{1}{4}$) of the northwest quarter (NW $\frac{1}{4}$) of Sec 10, T21S, R61E, MDM or at a point from which the northwest corner of said Sec 10, bears north 15°40'00" west a distance of 917.0 feet.**
7. Proposed place of use **portion of the northeast quarter (NE $\frac{1}{4}$) of the southeast quarter (SE $\frac{1}{4}$) of the southwest quarter (SW $\frac{1}{4}$) of Sec 26, T21S, R60E, MDM being Lots One and Two of Land Divisions 5-87, APN 163-26-404-001 and 002 4.45 acres.**
8. Existing place of use **portion of the northeast quarter (NE $\frac{1}{4}$) of the northeast quarter (NE $\frac{1}{4}$) of Sec 9 and a portion of the northwest quarter (NW $\frac{1}{4}$) of the northwest quarter (NW $\frac{1}{4}$) of Sec 10, T21S, R61E, MDM.**
9. Use will be from **January 1st to December 31st** of each year.
10. Use was permitted from **January 1st to December 31st** of each year.
11. Description of proposed works **well is complete, install totalizing meter**
12. Estimated cost of works **\$1,000 ±**
13. Estimated time required to construct works **none, well is complete, consisting of an 8" steel casing, 500 feet deep, 5Hp pump, two pressure tanks and appruntenances**
14. Estimated time required to complete the application of water to beneficial use **3 years**
15. Remarks: **Water to be used for existing residence, horse purposes, miscellaneous livestock, landscaping and small orchard.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 24582, Certificate 7673 is issued subject to the terms and conditions imposed in said Permit 24582, Certificate 7673 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Permit 68550 is granted to provide water service to two lots described by Clark County Assessor's Parcel Numbers 163-26-404-001 and 163-26-404-002.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0066 cubic feet per second, but not to exceed 3.0 acre-feet annually.

Work must be prosecuted with reasonable diligence and be completed on or before:

February 18, 2004

Proof of completion of work shall be filed on or before:

March 18, 2004

Water must be placed to beneficial use on or before:

February 18, 2005

Proof of the application of water to beneficial use shall be filed on or before:

March 18, 2005

Map in support of proof of beneficial use shall be filed on or before:


