The applicant **Stuart L. Brown, D.B.A. Double Horseshoe Ranch L.L.C.**, hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **Natural Channel Coyote Reservoir N.W.**
2. The amount of water applied for is **.025** second-feet
 - (a) If stored in reservoir give number of acre-feet **1.25**
3. The water to be used for **Stockwater**
4. If use is for:
 - (a) Irrigation, state number of acres to be irrigated
 - (b) Stockwater, state number and kinds of animals to be watered **97 Head of Cattle**
 - (c) Other use (describe fully under No. 12. "Remarks")
 - (d) Power:

 - (2) Point of return of water to stream
5. The water is to be diverted from its source at the following point **NW, SE, Sec. 31, T43N, R22E, M.D.B.M., or at a point from which the NW Cor. of Sec. 6, T42N, R22E, M.D.B.M., bears S 53°13'9" W, a distance of 4,239.51'.**
6. Place of Use **BLM grazing permit, deeded land, see attachment A.**
7. Use will begin about **4-1** and end about **10-31** of each year.
8. Description of proposed works **100' long earthen dam, 9.0' spillway height, 0.42 Ac surface, 1.25 AF storage**
9. Estimated cost of works **\$6,000**
10. Estimated time required to construct works **earthen dam complete**
11. Estimated time required to complete the application of water to beneficial use **current use complete**

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to all existing rights on the source. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the period of use and the average number of livestock served from the waters of this source. The State retains the right to regulate the use of the water herein granted at any and all times but does not take responsibility for the use of the Federal range.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.003 cubic feet per second, or sufficient water for 97 head of cattle.

January 4, 2005

Water must be placed to beneficial use on or before:

December 4, 2005

Proof of the application of water to beneficial use shall be filed on or before:
