The applicant **AngloGold (Jerritt Canyon) Corporation**, hereby makes application for permission to change the **point of diversion of a portion of water heretofore appropriated under permit #65323**

1. The source of water is **underground**
2. The amount of water to be changed **0.04 c.f.s. (28.96 acre-feet annually)**
3. The water to be used for **mining, milling, de-watering and domestic**
4. The water heretofore permitted for **mining, milling, de-watering and domestic**
5. The water is to be diverted at the following point **within the SW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 8, T.40N., R.54E., M.D.M., from which the SW corner of Section 7, in said township, bears S.68 $^{\circ}$ 22'W., 8,606 feet distance**
6. The existing permitted point of diversion is located within **NW $\frac{1}{4}$ NE $\frac{1}{4}$ Section 18, T.40N., R.54E., M.D.M., from which the SE corner of Section 19, in said township bears S.9 $^{\circ}$ 12'E., 10,620 feet distance**
7. Proposed place of use **same as existing**
8. Existing place of use **T.39N., R.53E., M.D.M., Sections 1 through 24; T.39N., R.54E., Sections 5 through 8, 17 through 20; T.40N., R.53E., -all sections; T.40N., R.54E., - W $\frac{1}{2}$ Section 3, 4 through 8, 17 through 20, 29 through 32; T.41N., R.53E., -all sections; T.41N., R.54E., - Sections 5 through 8, 18 through 20, 29 through 33, W $\frac{1}{2}$ Section 34.**
9. Use will be from **January 31 to December 31** of each year.
10. Use was permitted from **January 31 to December 31** of each year.
11. Description of proposed works. (Under the provisions of NRS 535.010 you may be required to submit plans and specifications of your diversion or storage works.) **The proposed point of diversion is the site chosen for a re-injection well, to be completed under provisions of NDEP U.I.C. permit #UNEV93214. Water developed in this well during its construction can be beneficially used in general mining and milling purposes.**
12. Estimated cost of works **\$200,000.00**
13. Estimated time required to construct works **one year**
14. Estimated time required to complete the application of water to beneficial use

15. Remarks: For use other than irrigation or stock watering, state number and type of units to be served or annual consumptive use. **Place of use is shown on map filed under application #65323. Points of diversion are shown on map accompanying temporary change application #67070T. Construction period has been prolonged; thus this replacement temporary application is being filed.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the point of diversion of a portion of the waters of an underground source as heretofore granted under Permit 65323 is issued subject to the terms and conditions imposed in said Permit 65323 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permit 39881, Certificate 11893; 42687; Permit 47148, Certificate 13139; 47414; Permit 48175, Certificate 13143; Permit 54617, Certificate 14301; 58336; 58426-E; 58427-E; 58428-E; 58429-E; 58430-E; 58431-E; 58432-E; 58433-E; 58744-E; 59274; Permit 61722, Certificate 15094; 61740-E; 61780-E; 61781-E; 61946; 62308; 62374; 65323; 65324 and Temporary Permit 68623-T will not exceed 5847.33 acre-feet annually (AFA).

This permit is issued under the preferred use provisions of NRS Chapter 534. The manner of use of water under this permit is by nature of its activity a temporary use and any application to change the manner of use granted under this permit will be subject to additional determination and evaluation with respect to the permanent effects on existing rights and the resource within the ground water basin.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Monthly measurements shall be kept and submitted to the State Engineer within 15 days after the end of each calendar quarter which shall include: (a) the volume of water pumped from each source, (b) the rate of diversion pumped from each source, (c) the measurement of pumping water level (drawdown) from each source, and (d) the volume of water consumptively used for mining and milling purposes and the amount of water re-injected.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on **June 23, 2003** at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.04 cubic feet per second, 28.96 acre-feet annually.


