The applicant DENNIS CAWRSE and JOANNE CAWRSE, husband and wife, as joint tenants, hereby make application for permission to change the POINT OF DIVERSION FOR A PORTION OF AND THE PLACE OF USE FOR A PORTION of water heretofore appropriated under APPLICATION 17965, CERTIFICATE 6394

- 1. The source of water is UNDERGROUND
- 2. The amount of water to be changed 52.04 A.F.A., 13.010 ACRES
- 3. The water to be used for IRRIGATION AND DOMESTIC
- 4. The water heretofore permitted for IRRIGATION AND DOMESTIC
- 5. The water is to be diverted at the following point WITHIN THE SE¼ OF THE NW¼ OF SEC. 10, T26N, R43E, MDM, AT A POINT FROM WHICH THE SW CORNER OF SAID SEC. 10 BEARS S 44°17' W 3706 FT.
- 6. The existing permitted point of diversion is located within SE¼ OF THE SW¼ OF SEC. 29 T26N, R43E, MDM, AT A POINT FROM WHICH THE SW CORNER OF SAID SEC. 29 BEARS S 78°32' W, 2715.0 FEET
- 7. Proposed place of use W½ OF SEC 10 (52.040 AFA, 13.010 ACRES)
- 8. Existing place of use W½ OF SEC 29, T26N, R43E, MDM 5.34 ACRES WITHIN THE NE¼ NW¼, 4.46 ACRES WITHIN THE NW¼ NW¼, AND 3.21 ACRES WITHIN THE SW¼ NW¼ SEC. 29, T26N, R.43E, MDB&M TO BE REMOVED. 13.01 ACRES TOTAL
- 9. Use will be from MARCH 1 to NOVEMBER 1 of each year.
- 10. Use was permitted from MARCH 1 to NOVEMBER 1 of each year.
- 11. Description of proposed works MOVE EXISTING PIPE AND SPRINKLER SYSTEM
- 12. Estimated cost of works LABOR ONLY TO MOVE EXISTING PIPE AND SPRINKLERS

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 17965, Certificate 6394 is issued subject to the terms and conditions imposed in said Permit 17965, Certificate 6394 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 68637, 68639, 68640, 68641 and 68642 shall not exceed 511.632 acre-feet annually for the irrigation of 127.908 acres within the described place of use.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed .183 cubic feet per second, but not to exceed 52.04 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:

December 12, 2003

Proof of completion of work shall be filed before:

January 12, 2004

Water must be placed to beneficial use on or before:

December 12, 2004

Proof of the application of water to beneficial use shall be filed on or before:

January 12, 2005

Map in support of proof of beneficial use shall be filed on or before:


