The applicant **City of North Las Vegas** hereby makes application for permission to change the **Point of Diversion** of water heretofore appropriated under **Permit No. 57329, Certificate No. 14382**

1. The source of water is **Las Vegas Artesian Basin (underground)**
2. The amount of water to be changed **0.50 cfs, not to exceed 75.2652 mil. gal. ann.**
3. The water to be used for **municipal purposes**
4. The water heretofore permitted for **municipal purposes**
5. The water is to be diverted at the following point **NW $\frac{1}{4}$  SE $\frac{1}{4}$  Section 7, T.20S., R.61E., M.D.B.&M., or at a point from which the C $\frac{1}{4}$  corner of said Section 7 bears N. 20°43'58" W., a distance of 267.13 feet situated in Clark County, State of Nevada.**
6. The existing permitted point of diversion is located within **NE $\frac{1}{4}$  NW $\frac{1}{4}$  Section 18, T.20S., R.62E., M.D.B.&M. or at a point from which the N $\frac{1}{4}$  corner of said Section 18 bears N. 65°26'01" E., a distance of 947.83 feet situated in Clark County, State of Nevada.**
7. Proposed place of use **see attached sheet**

9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Deep well with turbine pump and 500 h.p. electric motor**
12. Estimated cost of works **\$300,000**
13. Estimated time required to construct works **Completed: 910' deep, 24" borehole with 900' of 16" casing. 100' of 26" conductor casing at surface, perforated interval - 680' to 890'.**
14. Estimated time required to complete the application of water to beneficial use **2 years**
15. Remarks: **The point of diversion is a well that is part of the municipal supply for the North Las Vegas Service District, which currently serves approximately 48,000 municipal customers. Consumptive use, including surface and groundwater, will be approximately 46,000 acre-feet.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion of the waters of an underground source as heretofore granted under Permit 57329, Certificate 14382 is issued subject to the terms and conditions imposed in said Permit 57329, Certificate 14382 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030.

The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The permittee shall report to the State Engineer on a quarterly basis the effect of pumping the well under this permit on other previously existing wells that are located within 2,500 feet of the well under this permit.

Any pumping of water under this permit may be limited or prohibited to prevent any unreasonable adverse effects on an existing domestic well located within 2,500 feet of the well under this permit, unless the holder of this permit and the owner of the domestic well have agreed to alternative measures that mitigate adverse effects.

Monthly records shall be kept of the amount of water pumped from this well and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.50 cubic feet per second, but not to exceed 230.98 acre-feet annually.
