The applicant **Fahnestock Family Trust 05-94, Harry G. and Joanne Fahnestock, Trustees**, hereby makes application for permission to change the **Point of Diversion and Place of Use** of water heretofore appropriated under **all of Permit No. 52868, Certificate No. 13916**

1. The source of water is **underground**
2. The amount of water to be changed **0.07169 cfs, 52.0 afa**
3. The water to be used for **Irrigation and Domestic**
4. The water heretofore permitted for **Irrigation and Domestic**
5. The water is to be diverted at the following point **the SW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 8, T.22N., R.21E., M.D.M., at a point from which the northwest corner of said Section 8 bears North 64°35'19" West a distance of 3312.50 feet.**
6. The existing permitted point of diversion is located within **the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 21, T.22N., R.21E., M.D.M., at a point from which the north one-quarter corner of said Section 21 bears North 72°08'47" West a distance of 1030.23 feet. (See Map to Accompany Proof of Beneficial Use for Permits 52868, 52869 & 53263.)**
7. Proposed place of use **13.0 acres within the NE $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 9, T.22N., R.21E., M.D.M., the exact location to be determined later. (A portion of Washoe County Assessor's Parcel No. 077-100-13.)**
8. Existing place of use **13.0 acres in the N $\frac{1}{2}$ of the NW $\frac{1}{4}$ of the NE $\frac{1}{4}$ of Section 21, T.22N., R.21E., M.D.M.. See Map to Accompany Proof of Beneficial Use for Permits 52868, 52869 & 53263.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Existing well, pump and irrigation system.**
12. Estimated cost of works **Existing**
13. Estimated time required to construct works **Existing**
14. Estimated time required to complete the application of water to beneficial use **1 year**
15. Remarks: **This water will be used to cultivate sod on property owned by Edward and Constance Hayes during the 2002 growing season. A permanent Application to Change will follow.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 52868, Certificate 13916 is issued subject to the terms and conditions imposed in said Permit 52868, Certificate 13916 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The well must be sealed with cement grout, concrete grout or neat cement from ground level to 100 feet.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Temporary Permits 68844-T, 68846-T, 68848-T and 68888-T shall not exceed 292.00 acre-feet seasonally.

This temporary permit is limited to the irrigation of 13.0 acres within the described place of use.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on **December 31, 2002** at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, not to exceed 0.072 cubic per second, but not to exceed 52.00 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:
