The applicant **Scott Jolcover**, hereby make application for permission to change the **Point of Diversion and Place of Use of a portion** of water heretofore appropriated under **Permit #46828 Certificate #11946**

1. The source of water is **underground**
2. The amount of water to be changed **.061cfs**
3. The water to be used for **mining and milling**
4. The water heretofore permitted for **mining and milling**
5. The water is to be diverted at the following point **from the SW $\frac{1}{4}$ SE $\frac{1}{4}$ Section 6, T16N R21E MDM, or at a point from which the SE corner of said section 6 bears S 57°56'12" E a distance of 1799 Feet**
6. The existing permitted point of diversion is located within **SE $\frac{1}{4}$ NE $\frac{1}{4}$ Section 12 T16N R20E MDBM, or at a point from which the SE corner of said Section 12 bears S 16°56' E a distance of 2,721.0 feet**
7. Proposed place of use **within the SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 6, T16N, R21E MDBM, Storey County, Nevada, APN #64-331-15**
8. Existing place of use **within the SE $\frac{1}{4}$ NW $\frac{1}{4}$ SE $\frac{1}{4}$ Section 18 and S $\frac{1}{2}$ NE $\frac{1}{4}$ NW $\frac{1}{4}$ SE $\frac{1}{4}$ Section 18, T16N., R21E, as shown on accompanying map**
9. Use will be from **Jan. 1 to Dec. 31** of each year.
10. Use was permitted from **Jan. 1 to Dec. 31** of each year.
11. Description of proposed works **well drilled under permits 54503 see attached well log #24627**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions.

This temporary permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 46828, Certificate 11946 is issued subject to the terms and conditions imposed in said Permit 46828, Certificate 11946 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

This temporary permit is issued under the preferred use provisions of NRS Chapter 534. The manner of use of water under this temporary permit is by nature of its activity a temporary use and any application to change the manner of use granted under this temporary permit will be subject to additional determination and evaluation with respect to the permanent effects on existing rights and the resource within the ground water basin.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The total combined duty of water under Permit 46828 and Temporary Permit 68887-T shall not exceed 12.03 million gallons annually.

Monthly records shall be kept of the amount of water pumped from this well and the well under Permit 46828 and the records submitted to the State Engineer on a quarterly basis within 15 days after the end of each calendar quarter.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on **October 1, 2003** at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.061 cubic feet per second, **but not to exceed 11.03 million gallons annually.**


