This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the place of use and manner of use of the waters of Unnamed Springs and Tributaries heretofore granted under Permit 12083, Certificate 3908, is issued subject to the terms and conditions imposed in said Permit 12083, Certificate 3908, and with the understanding that no other rights at the source shall be affected by the change proposed herein. A measuring device must be installed near the point of diversion and accurate measurements must be kept of water placed to a beneficial use. This permit is subject to the final allocation of the State of Nevada under the California-Nevada Interstate Compact Commission. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.0067 cubic feet per second.

April 23, 2005

May 23, 2005


