The applicant **Hoss Equipment Nevada Inc.** hereby makes application for permission to change the **Place of Use and Manner of Use** of water heretofore appropriated under a **portion of Permit # 60877. Well # 3**

1. The source of water is **Underground**
2. The amount of water to be changed **6.1 acre feet**
3. The water to be used for **Commercial. Ref. # 15 for further remarks.**
4. The water heretofore permitted for **Industrial (Gravel Operation)**
5. The water is to be diverted at the following point **NE $\frac{1}{4}$  SW $\frac{1}{4}$  Section 27 T20N, R22E, MDM. or at a point from which the W $\frac{1}{4}$  corner of said Section 27 bears N 87° 11' W 2017.4 feet**
6. The existing permitted point of diversion is located within
7. Proposed place of use **portions of Sections 1, 2, 11, 14, 15, 16, 21, 20, 19, T20N, R23E, MDM; and portions of Sections 21, 22, 23, 24, T.20N, R.22E, MDM. Refer to #15 for additional details.**
8. Existing place of use **All of Section 27 T20N, R22E, MDM.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **Clean out existing 12" well, install submersible pump and flow meter.**
12. Estimated cost of works **\$10,000**
13. Estimated time required to construct works **1 month**
14. Estimated time required to complete the application of water to beneficial use **6 months**
15. Remarks: **An existing well will be equipped to provide a temporary water supply to Tuscarora National Gas Pipeline Co. for hydrostatic testing of a natural gas pipeline to be constructed, and for dust control during the 6 mo. construction period.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the place of use and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 60877 is issued subject to the terms and conditions imposed in said Permit 60877 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the right of ingress and egress on public, private or corporate land.

The total combined duty of water under Permits 60877, 60878, 68861-T and Temporary Permit 68985-T shall not exceed 484 acre-feet annually.

The total combined diversion rate under Permit 60877 and Temporary Permits 68861-T, and 68985-T shall not exceed 0.668 cubic feet per second.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire **August 27, 2003** at which time all rights herein granted shall revert to the right being changed by this temporary permit.


