The applicant **South Crestview Homeowners Association, Inc.**, hereby makes application for permission to change the **point of diversion of a portion** of water heretofore appropriated under **Permit #31885**

1. The source of water is **Underground (Well #3)**
2. The amount of water to be changed **0.2 c.f.s. (90 g.p.m.)**
3. The water to be used for **quasi-municipal**
4. The water heretofore permitted for **quasi-municipal**
5. The water is to be diverted at the following point **NW¼ SW¼ Section 7, T.34N., R.55E., M.D.M., from which the SW corner of said Section 7 bears S. 0°35' E., 1609.4 feet distant.**
6. The existing permitted point of diversion is located within **SW¼ SW¼ Section 7, T.34N., R.55E., M.D.M. from which the SW corner of said Section 7, bears S. 0°05'12" W., 824.85 feet distant.**
7. Proposed place of use **Portions of SW¼ and SW¼ NW¼ Sec. 7, T.34N., R.55E., M.D.M. (as described in permits #31885 and 47412)**
8. Existing place of use **Portions of SW¼ and SW¼ NW¼ Sec. 7, T.34N., R.55E., M.D.M. (as described in permits #31885 and 47412)**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **drilled and cased well with gravel packing, submersible pump and motor, storage tanks and pipeline**
12. Estimated cost of works **\$80,000**
13. Estimated time required to construct works **one year**
14. Estimated time required to complete the application of water to beneficial use **five years**
15. Remarks: **A permanent change application will follow this application soon. Recent emergency use of stored water to fight range fire off property demonstrated vulnerability of existing system to provide adequate and timely supply & reserve. Applicant respectfully requests immediate response from state engineer, so that well development may commence.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions.

This temporary permit to change the point of diversion of a portion of the waters of an underground source as heretofore granted under Permit 31885 is issued subject to the terms and conditions imposed in said Permit 31885 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The well must be sealed with cement grout, concrete grout or neat cement from ground level to 100 feet.

The total combined duty of water under Permits 31885, 47412 and Temporary Permit 68994-T shall not exceed 14.6 million gallons annually.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on **October 1, 2003** at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.2 cubic feet per second, **but not to exceed 1.46 million gallons annually.**


