The applicant **BENTLY FAMILY LIMITED PARTNERSHIP** hereby makes application for permission to change the **Point of Diversion and Place of Use of Use** of water heretofore appropriated under **Carson River Claim Nos. 366**

1. The source of water is **The East Fork of the Carson River**
2. The amount of water to be changed **74.835 acre feet**
3. The water to be used for **As Decreed**
4. The water heretofore permitted for **As Decreed**
5. The water is to be diverted at the following point **SW ¼ SW ¼ of Section 24, T12N, R20E, MDB&M or at a point from which the South quarter corner of Section 23, T12N, R20E, MDB&M bears South 74° 41' 05" West a distance of 3,077 feet (Allerman Canal)**
6. The existing permitted point of diversion is located within **Ezell & McFanning – Joint Diversion with Emigrant, Banning & McFanning, & Martin SLG Ditches in NE ¼ SW ¼ Section 14, T12N, R20E, MDM as described on Page 58 of the Carson River Decree.**
7. Proposed place of use **16.63 acres within the SE ¼ SW ¼ of Section 23 and the NE ¼ NW ¼ of Section 26 all in T13N, R20E, MDM, Douglas County, Nevada**
8. Existing place of use **16.63 acres within the SW ¼ of Section 33, T13N, R20E, MDM, Douglas County, Nevada**
9. Use will be from **As Decreed**
10. Use was permitted from **As Decreed**
11. Description of proposed works **Existing diversion structure in the East Fork of the Carson River – Allerman Canal to ditches, then pumping station to portable solid set sprinklers**
12. Estimated cost of works **Approximately \$20,000**

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit to change the point of diversion and place of use of Claim No. 366 of the Carson River as heretofore granted under the Final Carson River Decree No. D-183, in the District Court of the United States in and for the District of Nevada, is issued subject to the terms, conditions and irrigation period imposed in said Final decree and with the understanding that no other rights on the source will be affected by the change proposed herein.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This permit is limited to the irrigation of 16.63 acres within the proposed place of use.

The combined area to be irrigated from the Carson River under Permits 67869, 67870, 67871, 67872, 67873, 68443, 68444, 68997, 68998, 68999, 69000, 69001, 69002, 69003 and 69004 is limited to 555.18 acres within the proposed place of use.


