The applicant **Florida Canyon Mining, Inc.** hereby make application for permission to change the **Point of Diversion, Place of use of a portion of water** heretofore appropriated under **Permit 48998, Certificate 13238 (Production Well - 1 (PW-1))**

1. The source of water is **Underground**
2. The amount of water to be changed **0.081 C.F.S. or 19.11 M.G.A.**
3. The water to be used for **Mining, Milling and Domestic**
4. The water heretofore permitted for **Mining, Milling and Domestic**
5. The water is to be diverted at the following point (PW-2) **NE $\frac{1}{4}$ NW $\frac{1}{4}$ (lot 2) Section 3, T.31N., R.33E., M.D.B.&M. or at a point which the SW corner of said Section 3 bears S. 23° 15' W., a distance of 4980 feet. Refer to place of use map submitted with application #48997, #57096 and #61203 (PW-2).**
6. The existing permitted point of diversion is located within (PW-1) **SE $\frac{1}{4}$ NW $\frac{1}{4}$ (Lot 1) Section 3, T.31N., R.33E., M.D.B.&M. or at a point from which the SW corner of said Section 3, bears S. 31° W., a distance of 3810 feet. Map on file (Refer to place of use map submitted with application # 48998 and #57097 (PW-1).**
7. Proposed place of use **Sections 1, 2, 3, 4, 9, 10, 11, 12, 13, 14, 15, 16, 37, 38, 39, T.31N., R33E., M.D.B.&M. and Sections 33, 34, and 35, T.32N., R.33E., M.D.B.&M.**
8. Existing place of use **Sections 2, 3, 4, 9, 10, 11, 14, 15, 16, 37, 38, and 39, T.31N., R33E., M.D.B.&M.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works **The proposed PW-2 Well is located approximately 1385-ft north of PW-1. The water is pumped from the well to a cooling pond where it is metered as it is pumped out for mining, milling and domestic use.**
12. Estimated cost of works **(\$250,000) Two Hundred and Fifty Thousand Dollars**
13. Estimated time required to construct works **One Month**
14. Estimated time required to complete the application of water to beneficial use **Five Years**

15. Remarks: 19.11 million gallons estimated for annual consumptive use. This request allows us to more evenly distribute our allocated annual use between these two wells, thereby continuing production when production well one (PW#1) is being refurbished. This is an ongoing job due to the geothermal corrosive nature of the water.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions.

This temporary permit to change the point of diversion and place of use of a portion of the waters of an underground source as heretofore granted under Permit 48998, Certificate 13238 is issued subject to the terms and conditions imposed in said Permit 48998, Certificate 13238 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 48997, Certificate 13237; 48998, Certificate 13238; 48999, Certificate 13239; 49931, Certificate 13240; 50061, Certificate 13953; 50248, Certificate 14448; 53342, Certificate 13245; 57096, 57097, 57098, 61203, 61643, 61644, 61707, and Temporary Permits 68703-T, 68704-T, 69714-T and 69304-T shall not exceed 787 million gallons annually.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

Monthly records will be kept of the following: (a) the volume of water pumped from each well, (b) the volume of water consumptively used for mining and milling purposes projectwide and (c) the amount of water used for reclamation purposes. These records will be submitted within 15 days after the end of each month. Please also submit the water level (static or pumping) of each permitted well with the pumping report.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on **January 13, 2004** at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.081 cubic feet per second, but not to exceed 58.64 acre-feet annually.


