The applicant **South Meadows Properties, a limited partnership**, hereby makes application for permission to change the **Point of Diversion, Manner of Use, and Place of Use of a portion** of water heretofore appropriated under **Claim 719 of the final decree titled "In the District Court of the United States in and for the District of Nevada in Equity Docket No. A3, the United States of America, Plaintiff, vs. Orr Ditch Company, et al., Defendants."**

1. The source of water is **Thomas Creek**
2. The amount of water to be changed **282.43 af**
3. The water to be used for **Storage**
4. The water heretofore permitted for **As Decreed**
5. The water is to be diverted at the following point **SE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 4, T.18N., R.20E., M.D.B.&M., or at a point from which the NW corner of said Section 4 bears N. 57°24'41" W., a distance of 3,050.064 feet.**
6. The existing permitted point of diversion is located within **SE $\frac{1}{4}$ SW $\frac{1}{4}$ Section 7, T.18N., R.20E., M.D.B.&M., or at a point from which the center of Section 8, T.18N., R.20E., M.D.B.&M., bears N. 70°30'00" E., a distance of 6,550.0 feet (same as decreed point of diversion).**
7. Proposed place of use **To be determined under secondary permits. Storage reservoir is located within the NW $\frac{1}{4}$ Section 4, T.18N., R.20E., M.D.B.&M., and the SW $\frac{1}{4}$ Section 33, T.19N., R.20E., M.D.B.&M.**
8. Existing place of use **3.38 acres within the SW $\frac{1}{4}$ NW $\frac{1}{4}$; 40.0 acres within the SE $\frac{1}{4}$ NW $\frac{1}{4}$; 6.733 acres within the NW $\frac{1}{4}$ NW $\frac{1}{4}$; 25.20 acres within the NE $\frac{1}{4}$ NW $\frac{1}{4}$; all in Section 8, T.18N., R.20E., M.D.B.&M.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **As Decreed to As Decreed** of each year.
11. Description of proposed works **Headgates, ditches, and pipelines to dam and reservoir constructed under Permit J-325.**
12. Estimated cost of works **\$15,000,000.00**
13. Estimated time required to construct works **Completed under Orr Ditch Decree, Permit 55534, and Permit J-325.**
14. Estimated time required to complete the application of water to beneficial use **To be determined under secondary permit.**

15. Remarks: This application is intended to be a "Temporary Primary Permit for Storage" with the actual beneficial use of water to be determined under secondary permits. Said secondary permits are issued subject to the terms of this primary permit and will expire according to said terms. Please refer to map filed under Permit 55534 for the proposed point of diversion. This temporary application replaces a series of temporary permits, the last being Permit 68009T.

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This temporary permit to change the point of diversion, manner and place of use of a portion of the waters of the Thomas Creek as heretofore granted under Claim No. 719 of the Truckee River Decree, is issued subject to the terms and conditions imposed in said decree and with the understanding that no other rights on the source will be affected by the change proposed herein. This temporary permit is issued for the consumptive use portion only of the original Truckee River Decree rights (Claim 719) that being 2.5 acre-feet annually per acre, the remaining portion of the claim will go to make up downstream rights. Water measuring devices and totalizing meters must be installed and accurate records must be kept of the water diverted and placed into storage. A substantial measuring device must be installed and accurate records must be kept of the water flowing in Thomas Creek prior to its commingling with other drainages.

A monthly report of the water diverted and placed into storage must be submitted to the State Engineer and Federal Water Master on a monthly basis within 15 days after the end of each month.

This temporary permit is issued subject to the regulation of the irrigation season as established by the Federal Water Master.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on **June 11, 2004** at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 1.887 cubic feet per second, **but not to exceed 188.28 acre-feet annually.**
