APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions:

This permit is issued subject to existing rights. It is understood that the amount of water herein granted is only a temporary allowance and that the final water right obtained under this permit will be dependent upon the amount of water actually placed to beneficial use. It is also understood that this right must allow for a reasonable lowering of the static water level. This well shall be equipped with a two (2) inch opening for measuring depth to water. If the well is flowing, a valve must be installed and maintained to prevent waste. A totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of water begins, or before the Proof of Completion of Work is filed. This source is located within an area designated by the State Engineer, pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The total combined duty of water under Permits 69456 and 69457 shall not exceed 1,600 acre feet annually.

This permit is issued for the irrigation of 400 acres within the described place of use.

The issuance of this permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

The point of diversion and place of use are as described on the submitted application to support this permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 6.0 cubic feet per second or 1600.0 acre-feet annually, and not to exceed 4.0 acre-feet per acre from any and/or all sources.

Work must be prosecuted with reasonable diligence and proof of completion of work shall be filed on or before:

April 28, 2010

Water must be placed to beneficial use and proof of the application of water to beneficial use shall be filed on or before:

April 28, 2013

Map in support of proof of beneficial use shall be filed on or before:

April 28, 2013

The applicant **James M. Champie, Jr. dba Reese River Cattle Company** hereby makes application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **an underground source**
2. The amount of water applied for is **6.0 c.f.s. – 1,600 af/a** second-feet
 - (a) If stored in reservoir give number of acre-feet
3. The water to be used for **irrigation and domestic**
4. If use is for:
 - (a) Irrigation, state number of acres to be irrigated **400 acres**
 - (b) Stockwater, state number and kinds of animals to be watered
 - (c) Other use (describe fully under No. 12. "Remarks")
 - (d) Power:
 - (1) Horsepower developed

Place of Use **SW¼ NE¼, W½ SE¼ & SE¼ SE¼ Section 33; SW¼ & S½ SE¼ Section 34 T17N, R42E, MDM W½, W½ E½, SE¼ NE¼ & NE¼ SE¼ Section 3; E½, E½ W½ & SW¼ SW¼ Section 4; E½ SW¼ & W½ SE¼ Section 5, NE¼, E½ NW¼ & SW¼ NW¼ Section 8; NW¼, W½ NE¼ & NE¼ NE¼ Section 9; NW¼ NE¼ Section 10 T16N, R42E, MDM Totaling 400 acres irrigated within the above place of use – Hess Ranch**
