The applicant, **W. Dalton La Rue, Jr. and/or Anastasia J. La Rue dba Winnemucca Ranch**, hereby makes application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **underground source**
2. The amount of water applied for is **6.0 c.f.s. – 1,280 ac.ft./an. second-feet**
 - (a) If stored in reservoir give number of acre-feet
3. The water to be used for **irrigation and domestic purposes**
4. If use is for:
 - (a) Irrigation, state number of acres to be irrigated
 - (b) Stockwater, state number and kinds of animals to be watered
 - (c) Other use (describe fully under No. 12. "Remarks")
 - (d) Power:
 - (1) Horsepower developed
 - (2) Point of return of water to stream
5. The water is to be diverted from its source at the following point **within the SW¼ NW¼ Section 13, T.25.N, R.18E, M.D.M., or at a point from which the southeast corner of said Section 13 bears South 56°07'08' East a distance of 5767.01 feet. This proposed point of diversion will be within Newcomb Valley.**
6. Place of Use **SW¼ NW¼ & S½ Sect. 13 & NE¼ Sect. 24 T25N, R18E, MDM SW¼ Sect. 18; All Sect. 19; W½ Sect. 20 and N½ Sect. 29 T25N, R19E, MDM consisting of approximately 320 acres within the proposed place of use**
7. Use will begin about **January 1** and end about **December 31** of each year.
8. Description of proposed works **Drilled and cased well, equipped with motor, pump and pipeline to place of use**
9. Estimated cost of works **\$60,000.00**
10. Estimated time required to construct works **3 years**
11. Estimated time required to complete the application of water to beneficial use **8 years**
12. Remarks: **Applications 69550 & 69551 have been filed to irrigate 640 acres within the proposed place of use.**
