The applicant **Lewis A. Ewert, Trustee of Ewert Family 1995 Trust c/o Marvin Murphy, Lyle & Murphy, LLP**, hereby make application for permission to change the **The Point of Diversion and Place of Use** of water heretofore appropriated under **Permit No. 67906**

1. The source of water is **Underground**
2. The amount of water to be changed **0.1 cfs not to exceed 72.4 acre feet annually**
3. The water to be used for **Irrigation**
4. The water heretofore permitted for **Irrigation**
5. The water is to be diverted at the following point **Within NE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 25, T14N, R25E, MDM**
6. The existing permitted point of diversion is located within **NE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 6, T12N, R26E, MDM, or at a point from which the NE $\frac{1}{4}$ corner of said Section 6 bears N49°13'00"E. a distance of 1911.24 feet.**
7. Proposed place of use **SW $\frac{1}{4}$, W $\frac{1}{2}$ NW $\frac{1}{4}$ SE $\frac{1}{4}$, W $\frac{1}{2}$ SW $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 25 and NW $\frac{1}{4}$ NW $\frac{1}{4}$, NE $\frac{1}{4}$ NW $\frac{1}{4}$, W $\frac{1}{2}$ NW $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 36 T14N, R25E, MDM.**
8. Existing place of use **18.01 acres within the NW $\frac{1}{4}$ SW $\frac{1}{4}$, E $\frac{1}{2}$ SE $\frac{1}{4}$ SW $\frac{1}{4}$ of Section 32 and the NE $\frac{1}{4}$ SE $\frac{1}{4}$ Section 31, T14N, R26E, MDM.**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works. **Drilled and cased well, submersible pump and motor, and piping system to existing irrigation system.**
12. Estimated cost of works **\$75,000.00**
13. Estimated time required to construct works **1 year**
14. Estimated time required to complete the application of water to beneficial use **5 years**
15. Remarks: **The water under this temporary application to change Permit No. 67906, and the temporary application being filed concurrently to change Permit No. 67907, is for irrigation and is not to be supplemental to any other source of water.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions.

This temporary permit to change the point of diversion and place of use of the waters of an underground source as heretofore granted under Permit 67906 is issued subject to the terms and conditions imposed in said Permit 67906 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The well must be sealed with cement grout, concrete grout or neat cement from ground level to 100 feet.

The total combined duty of water under Temporary Permits 69814-T and 69815-T shall not exceed 200.5 acre-feet annually for irrigation of 50.125 acres within the described place of use.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on **June 30, 2004** at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.1 cubic feet per second, but not to exceed 48.5 acre-feet annually, and not to exceed a yearly duty of 4.0 acre-feet per acre of land irrigated from any and/or all sources.

Work must be prosecuted with reasonable diligence and be completed on or before:


