The applicant **Beverly Joan Jacob** hereby make application for permission to appropriate the public waters of the State of Nevada, as hereinafter stated.

1. The source of the proposed appropriation is **underground subterranean flows of water in basin deposits and/or solution cavities**
2. The amount of water applied for is **27,627** second feet.
 - (a) If stored in reservoir give number of acre-feet
3. The water to be used for **Hydroelectric power generation**
4. If use is for:
 - (a) Irrigation, state number of acres to be irrigated
 - (b) Stockwater, state number and kind of animals to be watered
 - (c) Other use (describe fully under No. 12. "Remarks")
 - (d) Power:
 - (1) Horsepower developed **6,267,636**
 - (2) Point of return of water to stream
5. The water is to be diverted from its source at the following point **SE¼ SE¼ Section 6 T4S R64E MDM bearing S 82° W 5,040 ft to SW Section Corner of said Section 6 (found BLM brass cap) Map 60190 60180**
6. Place of Use **Lincoln County as defined in NRS 243.210 thru 243.225 and in Clark County ad defined in NRS 243.035 thru NRS 243.010**
7. Use will begin about **January 1** and end about **December 31** of each year.
8. Description of proposed works **cased well to the subterranean water source; divert water into pipes, then transport by siphon & gravity flow**
9. Estimated cost of works **1.2 Billion (\$1,200,000,000.00)**
10. Estimated time required to construct works **Five (5) years**
11. Estimated time required to complete the application of water to beneficial use **Six (6) years**
