The applicant **United States Department of the Interior, Bureau of Land Management**, hereby makes application for permission to change the **Place of Use and Manner of Use of a Portion** of water heretofore appropriated under **Permit 50537, Certificate 134778**

1. The source of water is **Underground**
2. The amount of water to be changed **0.0580 CFS, 3.0 million gallons annually**
3. The water to be used for **Road Construction**
4. The water heretofore permitted for **Quasi Municipal and Domestic**
5. The water is to be diverted at the following point **Within the NW $\frac{1}{4}$  NE $\frac{1}{4}$  Section 15, T.19N., R.21E., MDM or at a point from which the N $\frac{1}{4}$  corner of said Section 15 bears N.17°54'06"W., 1331.02 feet.**
6. The existing permitted point of diversion is located within
7. Proposed place of use **Road to be constructed traverses through: N $\frac{1}{4}$  NE $\frac{1}{4}$ , SE $\frac{1}{4}$  NE $\frac{1}{4}$  SE $\frac{1}{4}$ , SE $\frac{1}{4}$  SW $\frac{1}{4}$  Section 15, T.19N., R.21E., MDM; NW $\frac{1}{4}$ , NE $\frac{1}{4}$  SW $\frac{1}{4}$  Section 22. T.19N., R.21E., MDM.**
8. Existing place of use **See attached Addendum #1**
9. Use will be from **January 1 to December 31** of each year.
10. Use was permitted from **January 1 to December 31** of each year.
11. Description of proposed works. **Water will be transferred from an existing fire hydrant to water trucks**
12. Estimated cost of works **No new costs. Road Construction will be at least \$1,000,000.**
13. Estimated time required to construct works **one year**
14. Estimated time required to complete the application of water to beneficial use **one year**
15. Remarks: **A new road will be constructed to the Lockwood Regional Landfill. It is estimated that approximately 2.0 million gallons of water will be used. A concurrent temporary application is being filed to temporarily transfer a portion of Permit 50536, Certificate 13478. Water will be used from wach permit. BLM will be filing Reports of Conveyance. However, this process may take longer than the proopsed start of construction.**

APPROVAL OF STATE ENGINEER

This is to certify that I have examined the foregoing application, and do hereby grant the same, subject to the following limitations and conditions.

This temporary permit to change the place of use and manner of use of a portion of the waters of an underground source as heretofore granted under Permit 50536, Certificate 13477 is issued subject to the terms and conditions imposed in said Permit 50536, Certificate 13477 and with the understanding that no other rights on the source will be affected by the change proposed herein. The well shall be equipped with a 2-inch opening and a totalizing meter must be installed and maintained in the discharge pipeline near the point of diversion and accurate measurements must be kept of water placed to beneficial use. The totalizing meter must be installed before any use of the water begins or before the proof of completion of work is filed. If the well is flowing, a valve must be installed and maintained to prevent waste. This source is located within an area designated by the State Engineer pursuant to NRS 534.030. The State retains the right to regulate the use of the water herein granted at any and all times.

This temporary permit does not extend the permittee the right of ingress and egress on public, private or corporate lands.

The issuance of this temporary permit does not waive the requirements that the permit holder obtain other permits from State, Federal and local agencies.

This temporary permit is issued pursuant to the provisions of NRS 533.345 Section 2 and will expire on **July 2, 2004** at which time all rights herein granted shall revert to the right being changed by this temporary permit.

The amount of water to be appropriated shall be limited to the amount which can be applied to beneficial use, and not to exceed 0.058 cubic feet per second, but not to exceed 3.0 million gallons annually.


